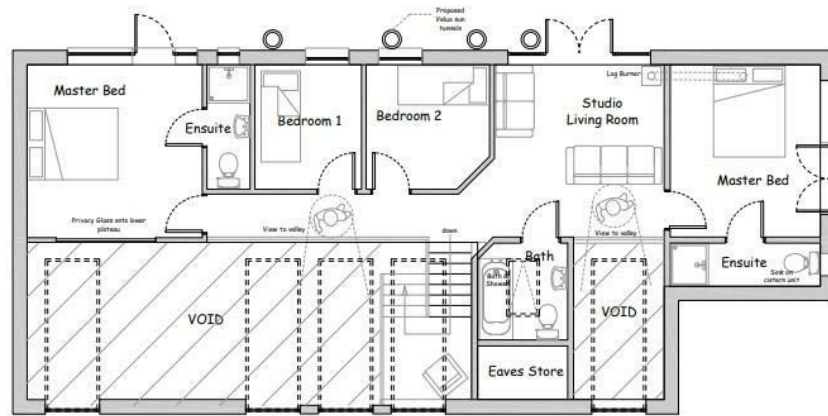

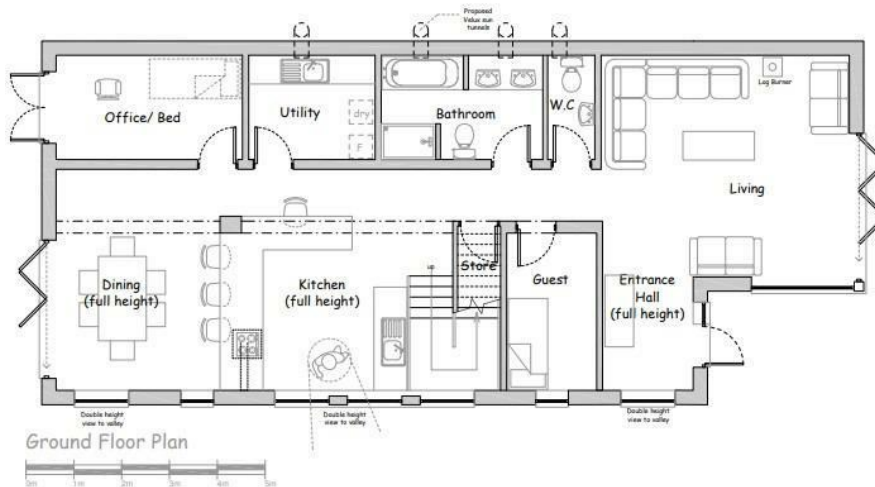




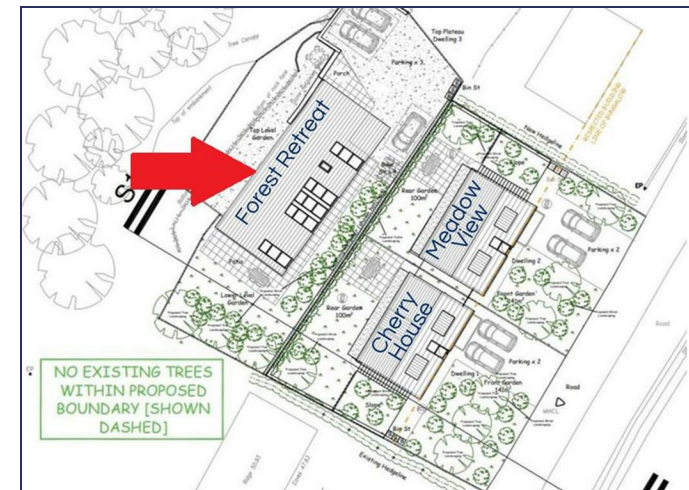




First Floor Plan
