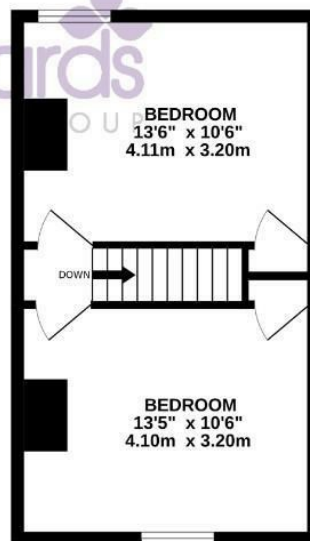

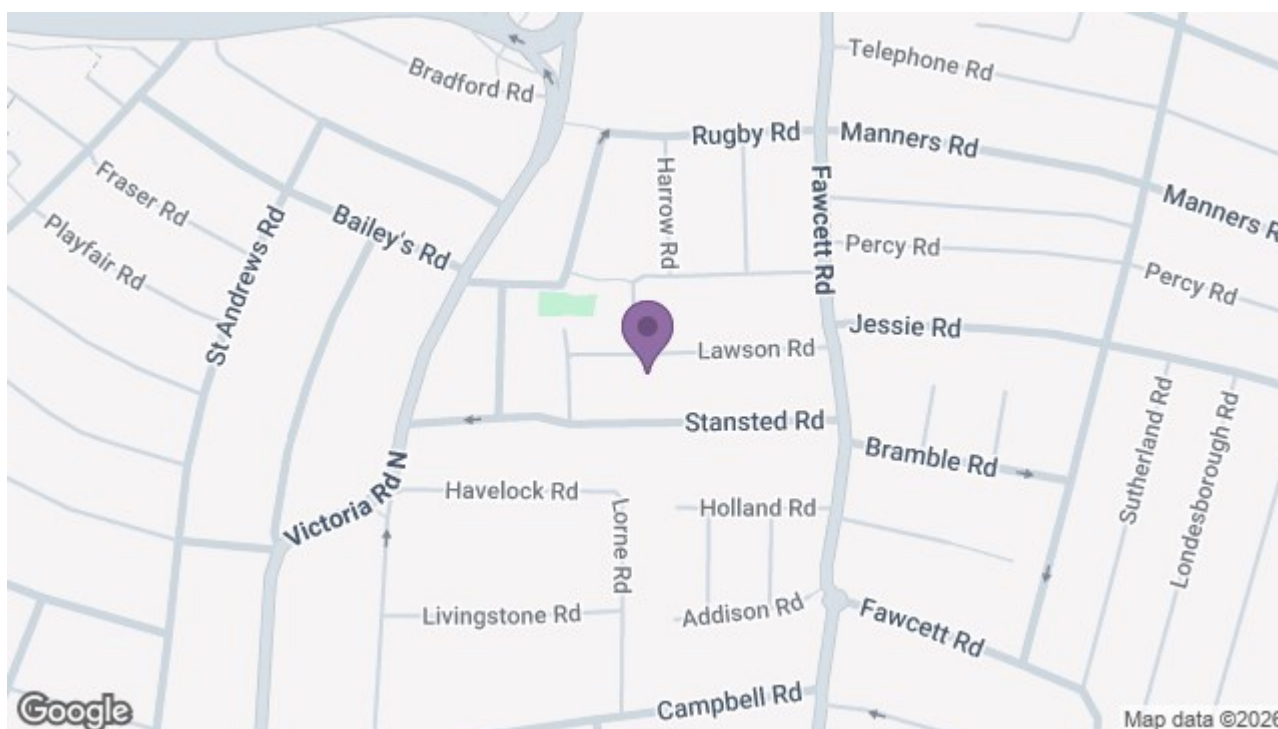


1ST FLOOR
