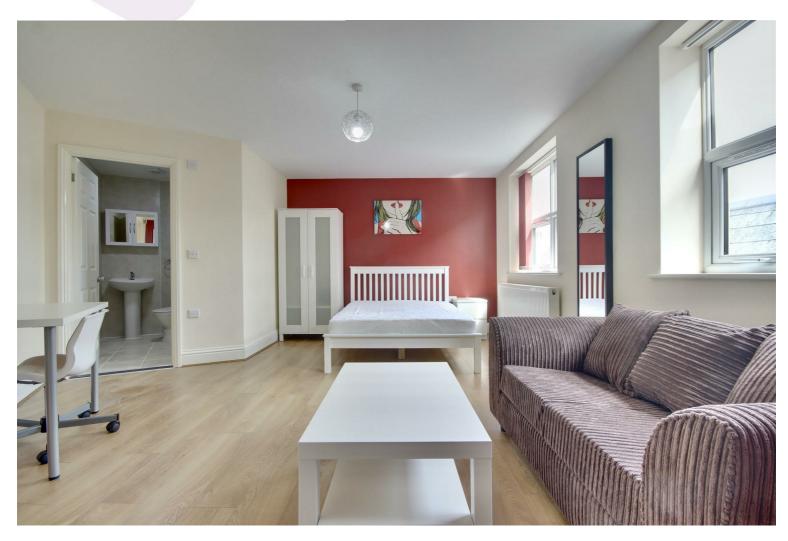

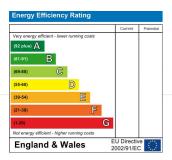
Right to Rent

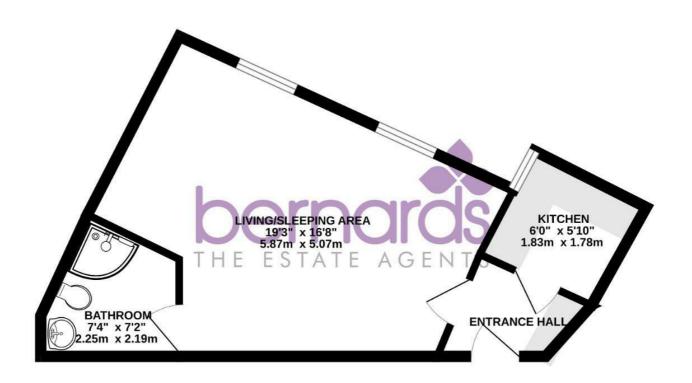
