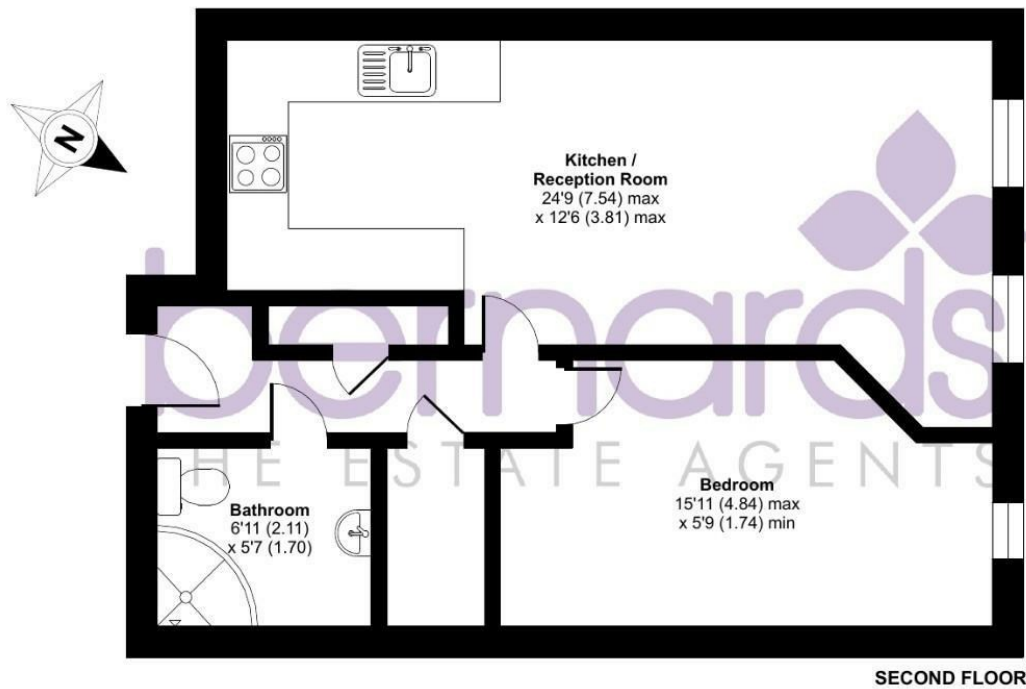

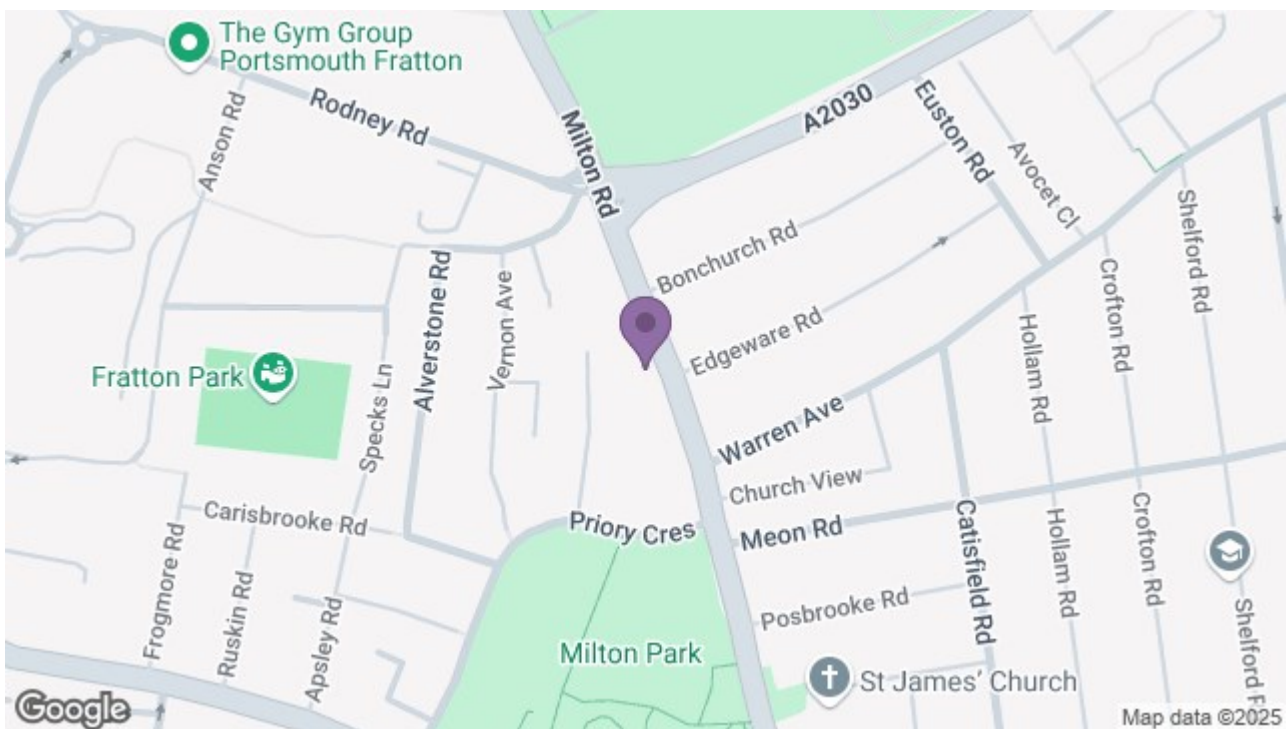
Holmes Park, Milton Road, Southsea, PO4
