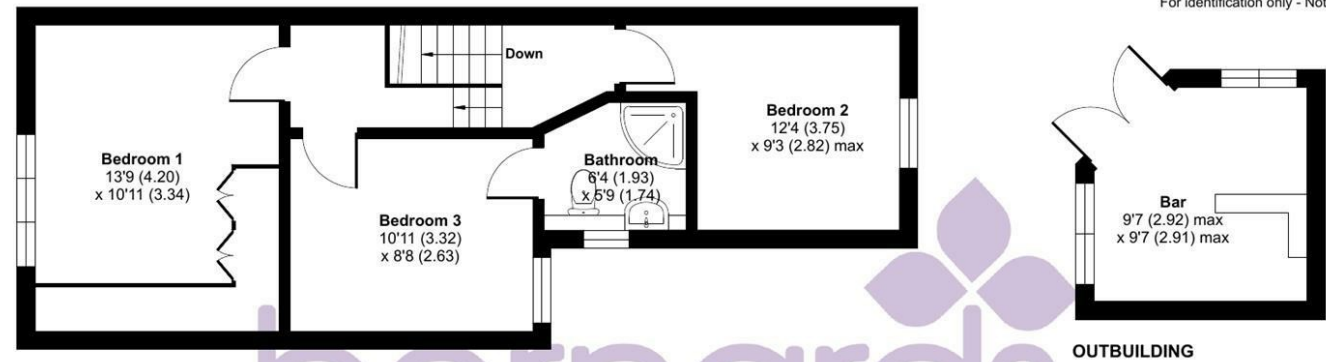

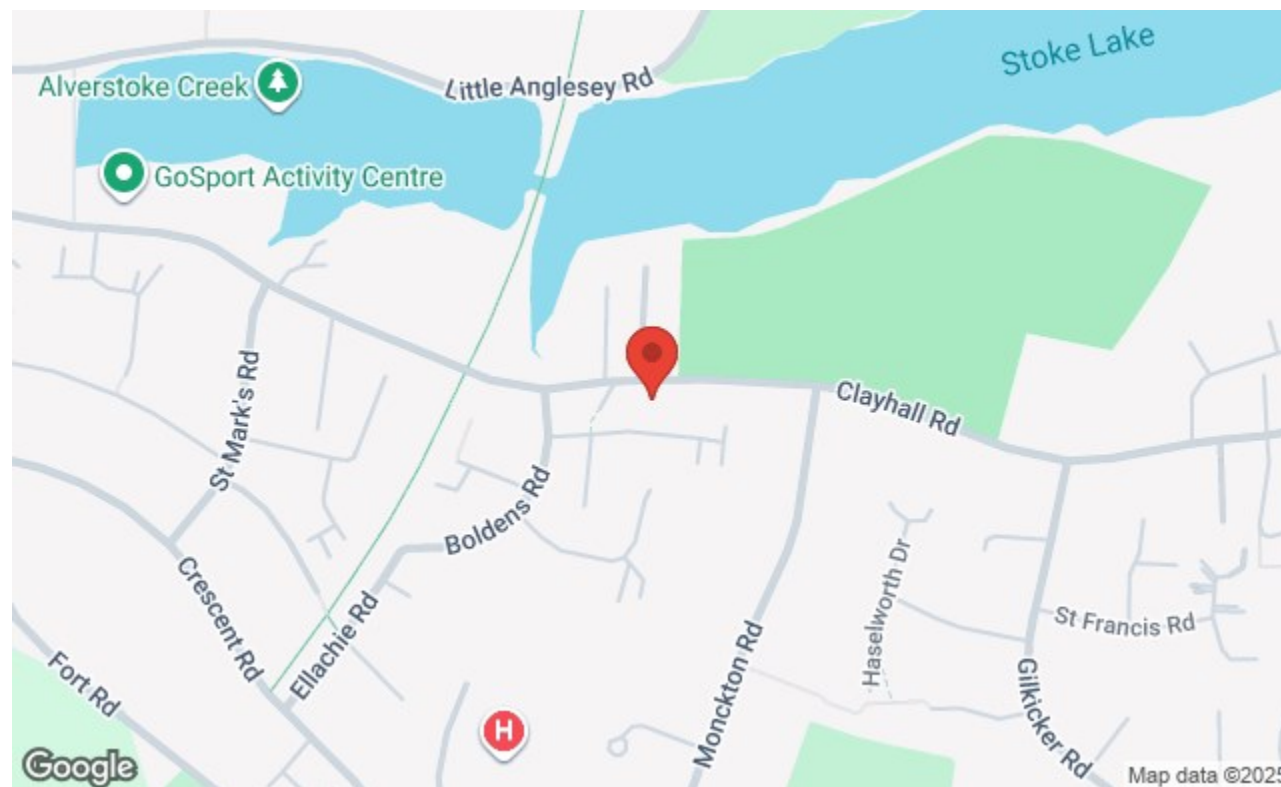
FIRST FLOOR

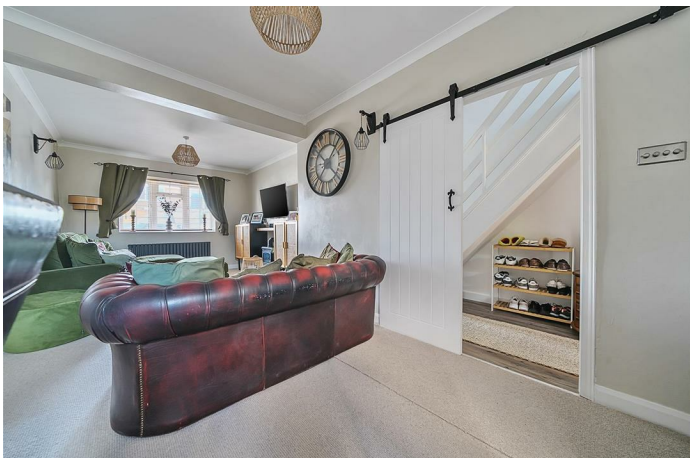
