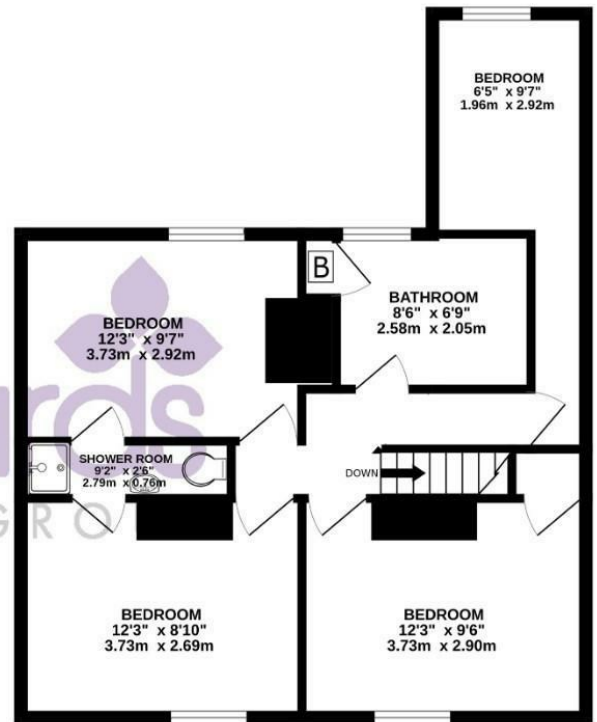
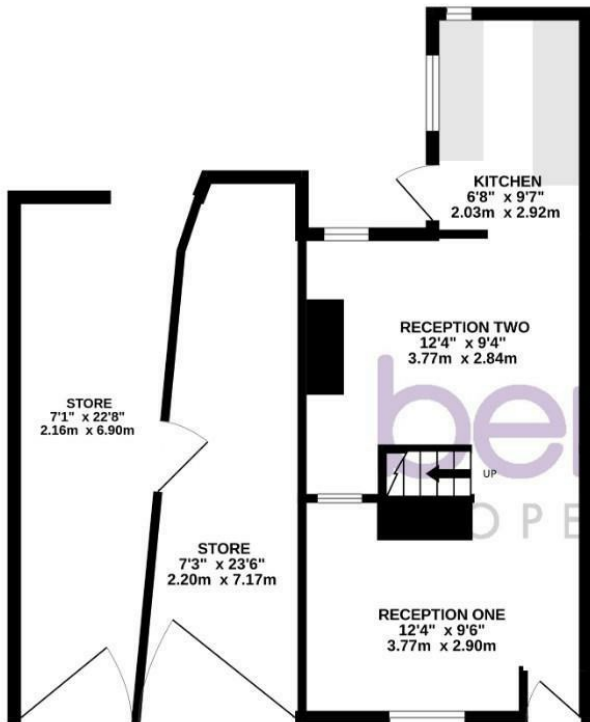
Auctioneers Additional Comments

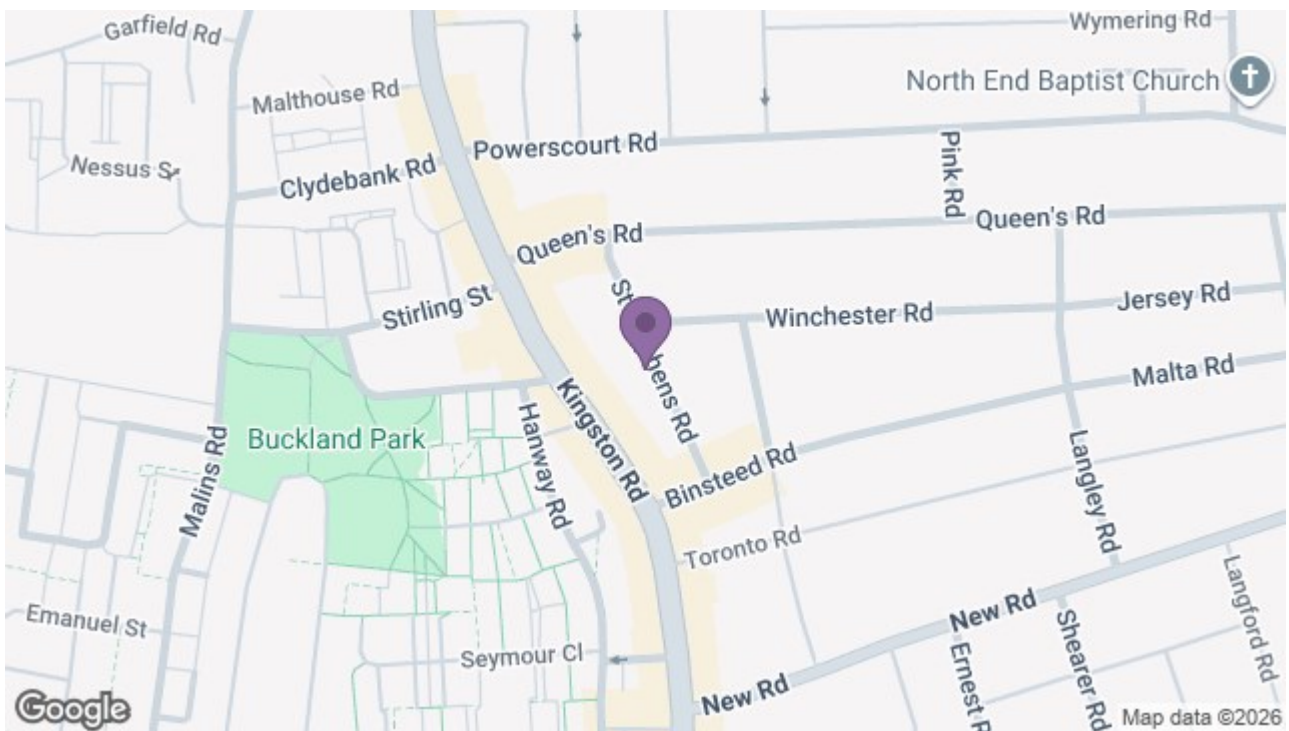
