The property is immaculately presented throughout - move straight in.

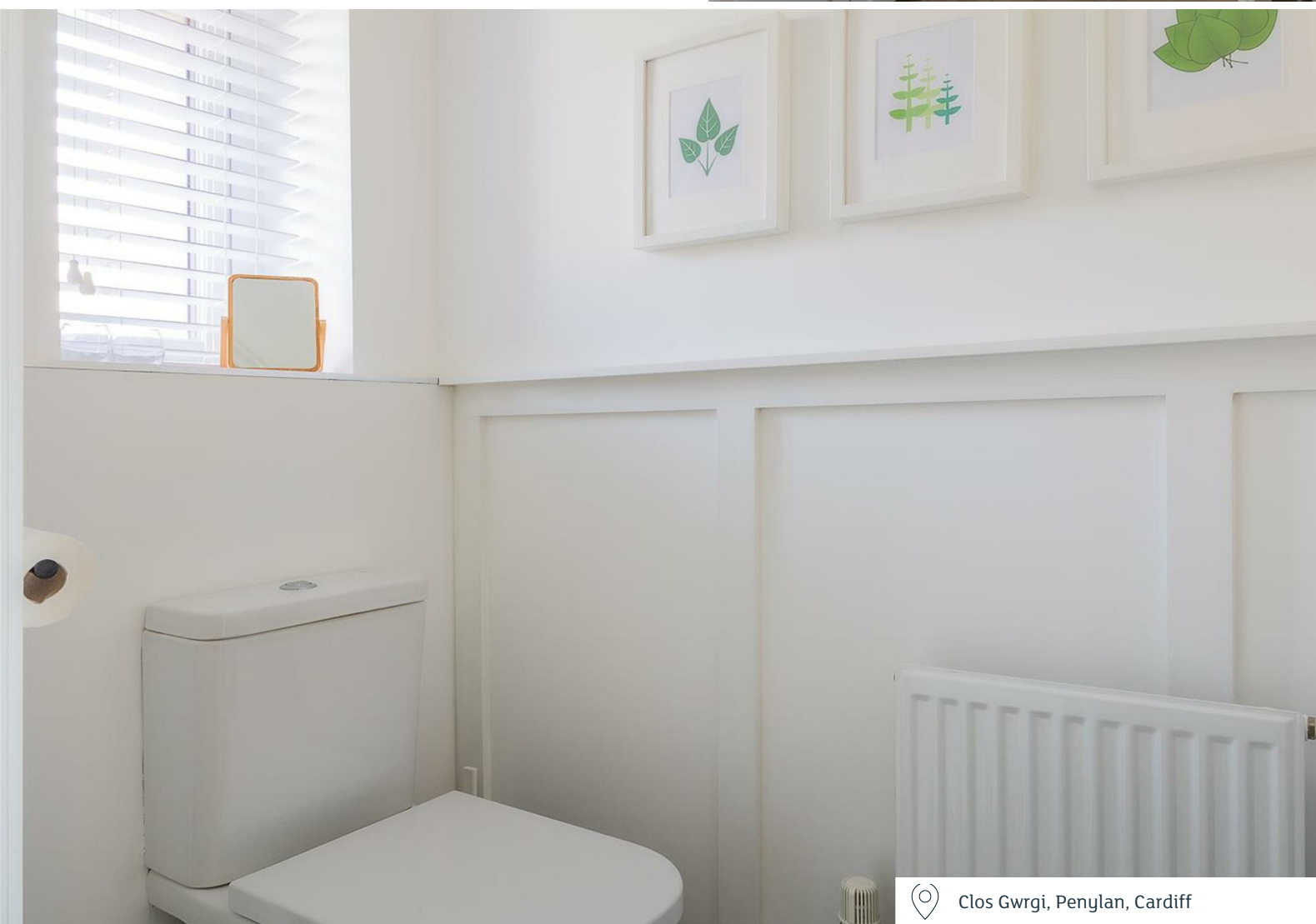

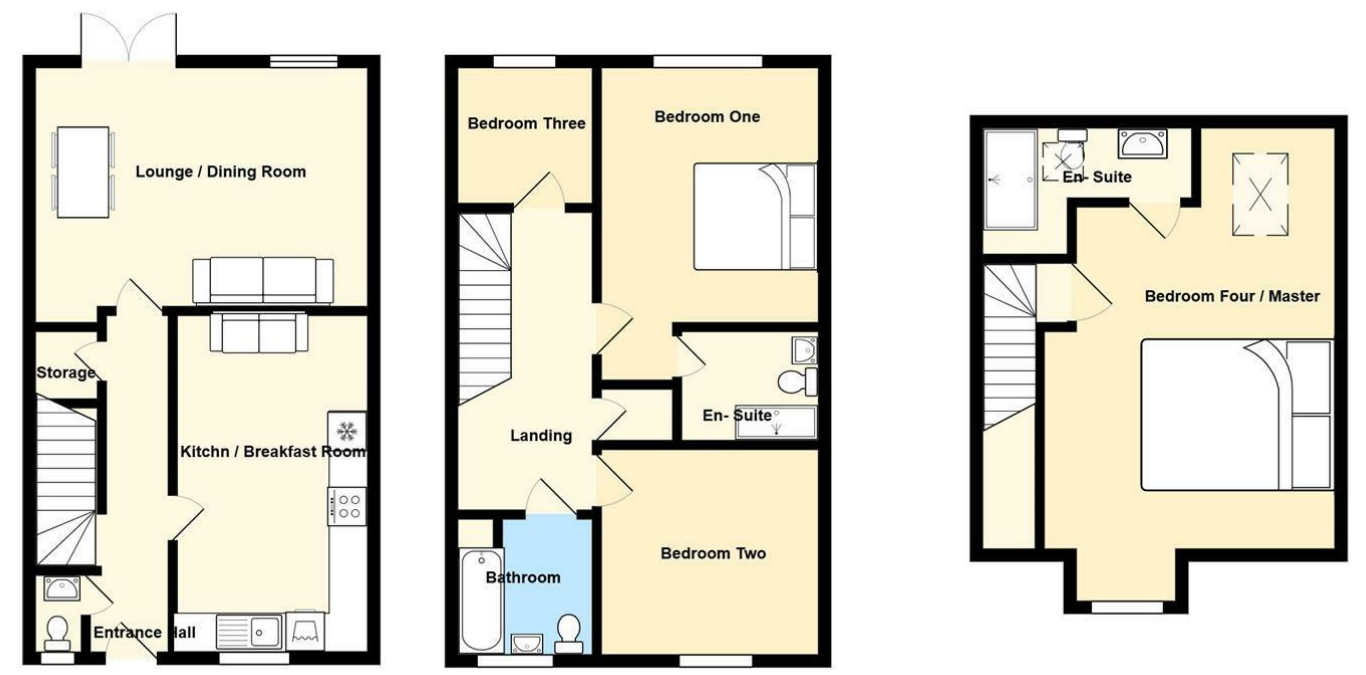
