SITUATION

The land is located about 0.7 mile west of Branscombe on the South coast of East Devon. The A3052 is situated about 1.5 miles north which connects Sidmouth (5 miles west) to Seaton (6.4 miles east.) The coast at Branscombe Beach is about 1.5 miles south of the land and the surrounding countryside comprises quiet rural valleys, pasture fields and woodland.

Branscombe is a village popular with walkers and tourists which benefits from two pubs, a Church and cafe/restaurant on Branscombe Beach. Sidmouth offers more extensive services, amenities and facilities suited to a regional town.

INTRODUCTION: AUCTION GUIDE £140,000 - £160,000

The land extends to about 13.73 acres which is separated into 2 fields of level and gently sloping pasture. Boundaries to the land are mature hedges with some larger trees.

The land abuts the public highway, Northern Lane, to the south and the public bridleway, Hole Hill, to the north.

The land has been used for seasonal grazing in recent years but would lend itself to a range of uses (stp).

SERVICES

No services connected.

ACCESS

Access to the public highway by a right of way over a public bridleway.

TENURE AND POSSESSION

Freehold and is available with vacant possession on completion.

PROOF OF IDENTITY

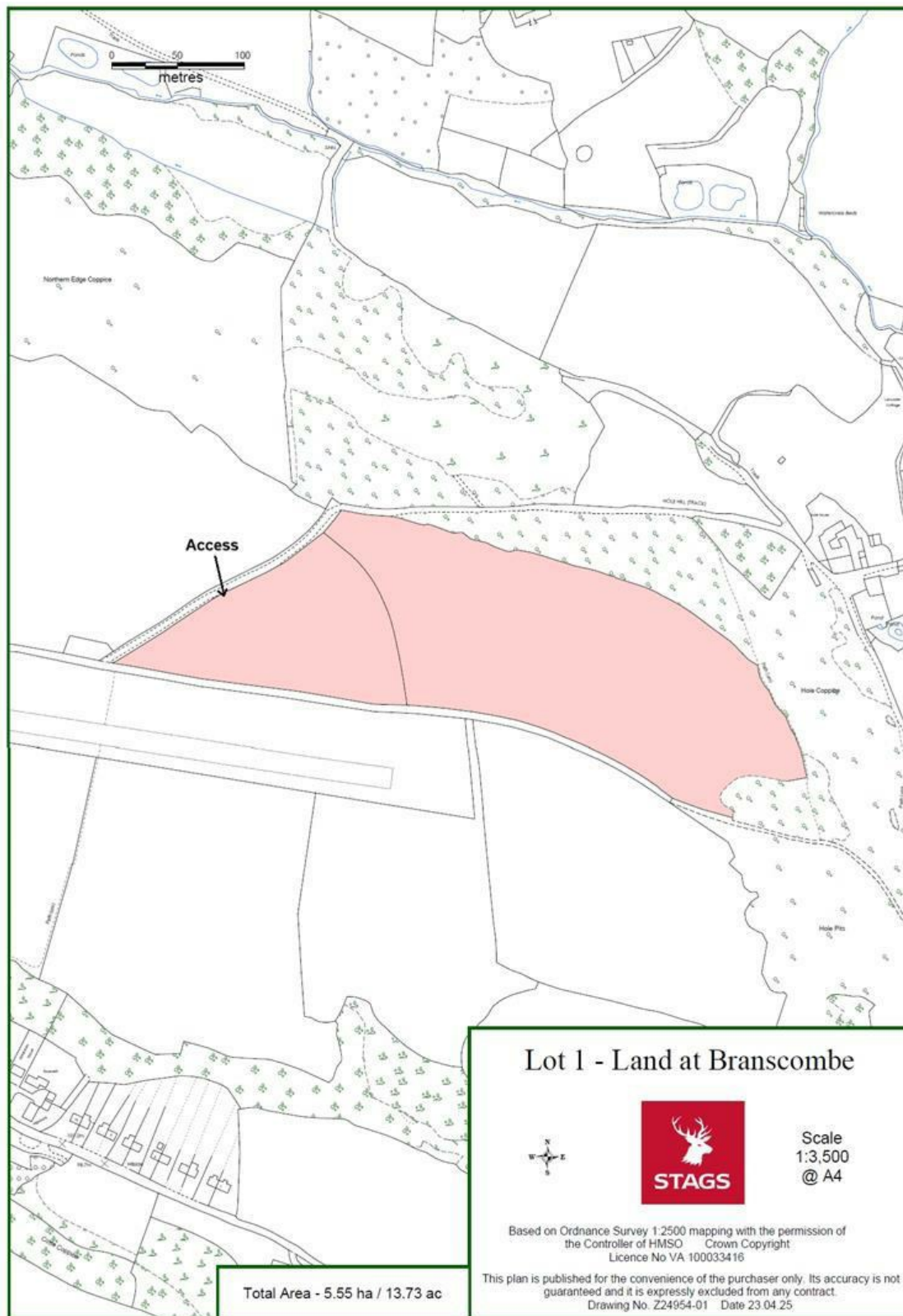
DIRECTIONS
