SITUATION

Old Barn occupies an easily accessible plot on the edge of the popular village of Abbotskerswell. The thriving local community is served by a well subscribed primary school, shop and post office, several local public houses and a well attended cricket club. Main roads giving quick access to Torbay, Plymouth, Exeter and the wider motorway network are close by. The busy market town of Newton Abbot has a wide range of services and amenities and a mainline railway station with fast and direct links to London Paddington. Recreational activities abound as some of the region's finest beaches, rivers and estuaries and Dartmoor National Park are a short drive away.

DESCRIPTION

The Old Barn is of limestone and cob construction and is believed to be several centuries old with a date of '1785' carved on the inside of the doorway. The barn has had a mixed history and was previously used as a cider store by Henleys and earlier still, was used to house animals and hay.

The grounds extend to the side of the barn towards the main road with a metal five bar gate providing access off of the lane. In total the site extends to 0.77 acres.

From Totnes take the A381 Newton Abbot road and, after approx 7.5 miles, turn right for Abbotskerswell and then immediately left into Manor Road. Pass the former cider works/industrial units and the entrance to Old Barn is on the left.

PROOF OF IDENTITY
