SITUATION

Canons Way is situated a short distance from the centre of the bustling Market Town of Tavistock. Tavistock is a popular market town which provides a good range of shopping facilities, various state schools and renowned private schools, including preparatory and a senior college. Recreational facilities include golf courses, rugby, football, tennis and indoor swimming clubs and The Wharf Cultural Centre. Plymouth, with its fascinating waterfront, some 14 miles away, offers facilities including a cross channel ferry port and mainline railway station with London Paddington approximately 3



hours away. The property itself is within walking distance to the town centre and is also serviced by a local bus with a bus stop close by.

DIRECTIONS

From Tavistock take the A390 signed posted to Callington/Gunnislake. Carry on up past the Catholic Church and then take the 2nd turning left into Monksmead. Go down around the bend and then turn right into Deacons Green. Carry down this road to the bottom of the road and turn left into Canons Way and No 2 can be found after a short distance on the left hand side.

LETTING.

The property is available to let on a assured shorthold tenancy for 12 months plus, unfurnished and is available immediately. RENT: £875 pcm exclusive of all charges .Children/pets considered. Where the agreed let permits pets the rent will be £900. DEPOSIT: £1009.
