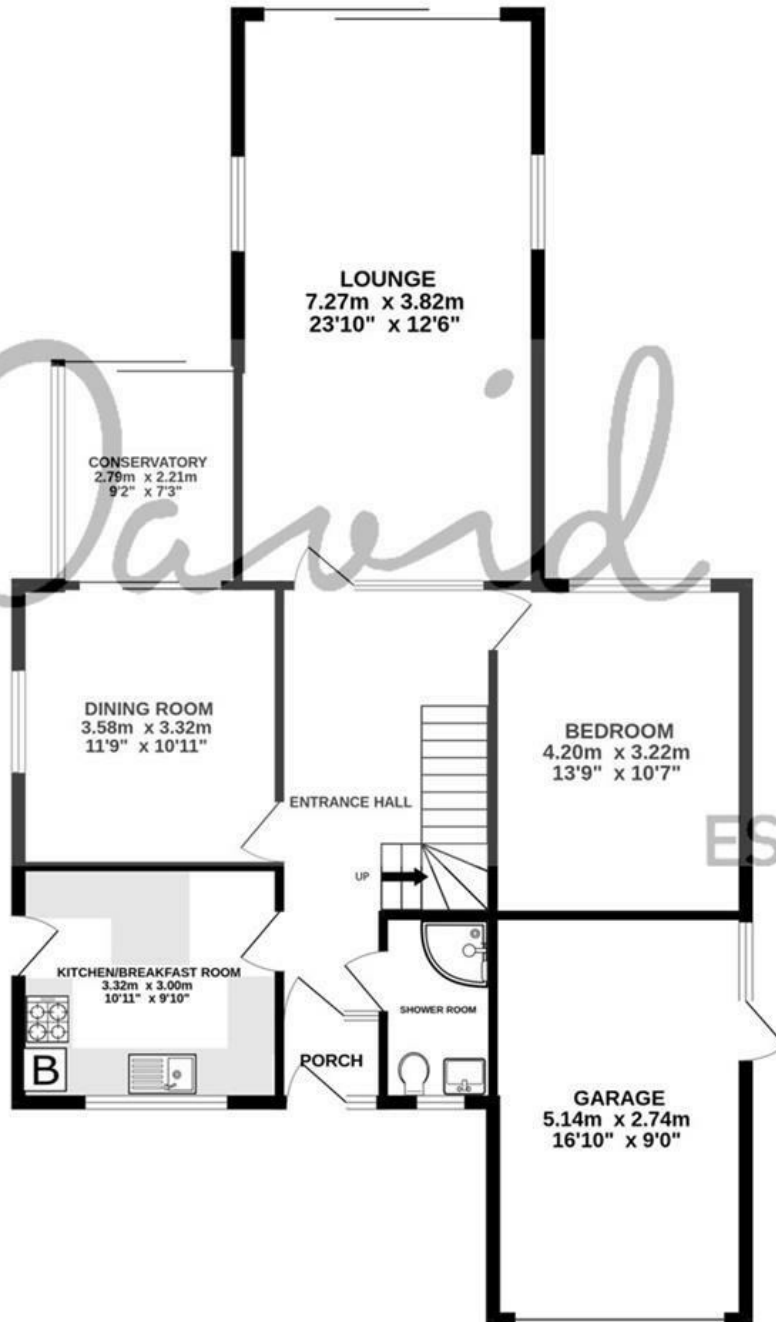
The first floor benefits from a light landing, two double bedrooms together with a family bathroom.

Further features and benefits include, off road parking for two vehicles, good sized North Westerly rear garden, garage, gas central heating and uPVC double glazing.

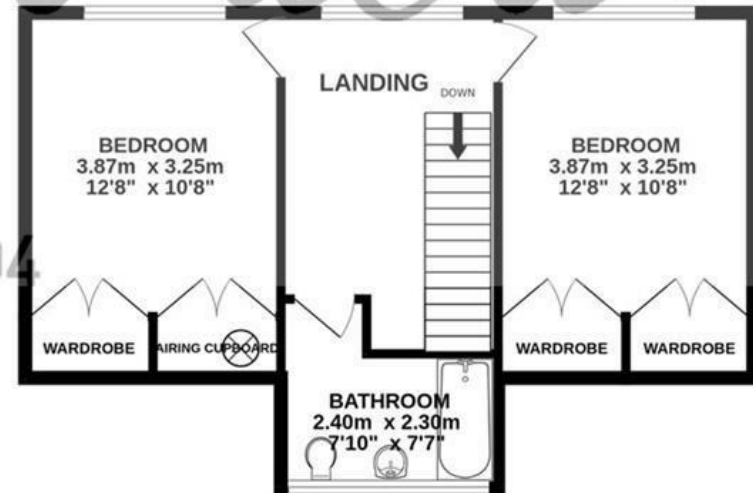

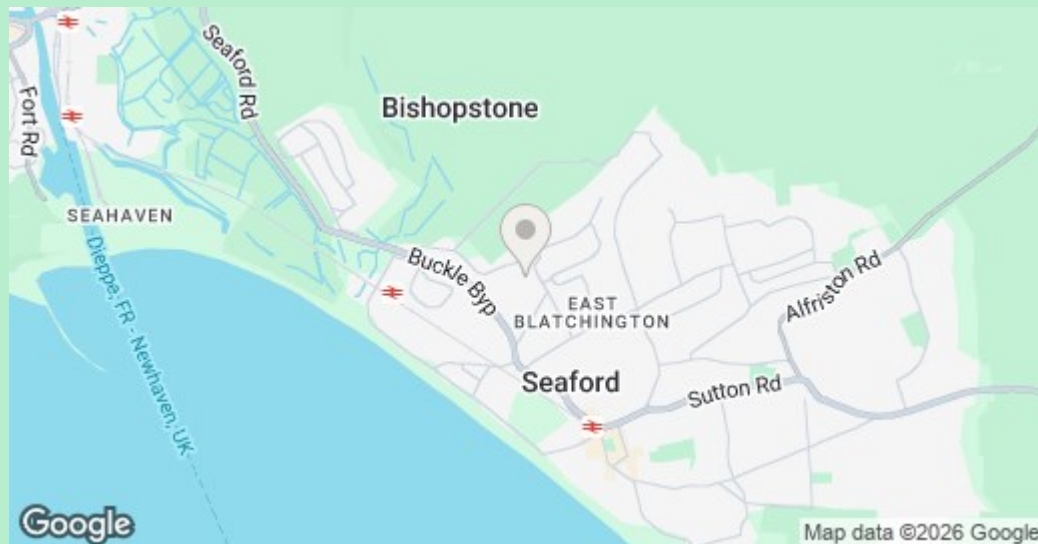
