Constructed in 2023 as part of the executive Bowyer design, this attractive and well presented four bedroom detached house is situated in this extremely convenient and popular location just north of the A259 main road. Close to Downs Leisure Centre, a parade of shops and bus routes. Seaford town centre is approximately one mile distant, whilst local primary and secondary schools are within approximately half a mile.

The accommodation comprises; entrance hall, kitchen/dining room with integrated AEG appliances and dual aspect sitting room. The ground floor also has the benefit of a cloakroom and utility room.

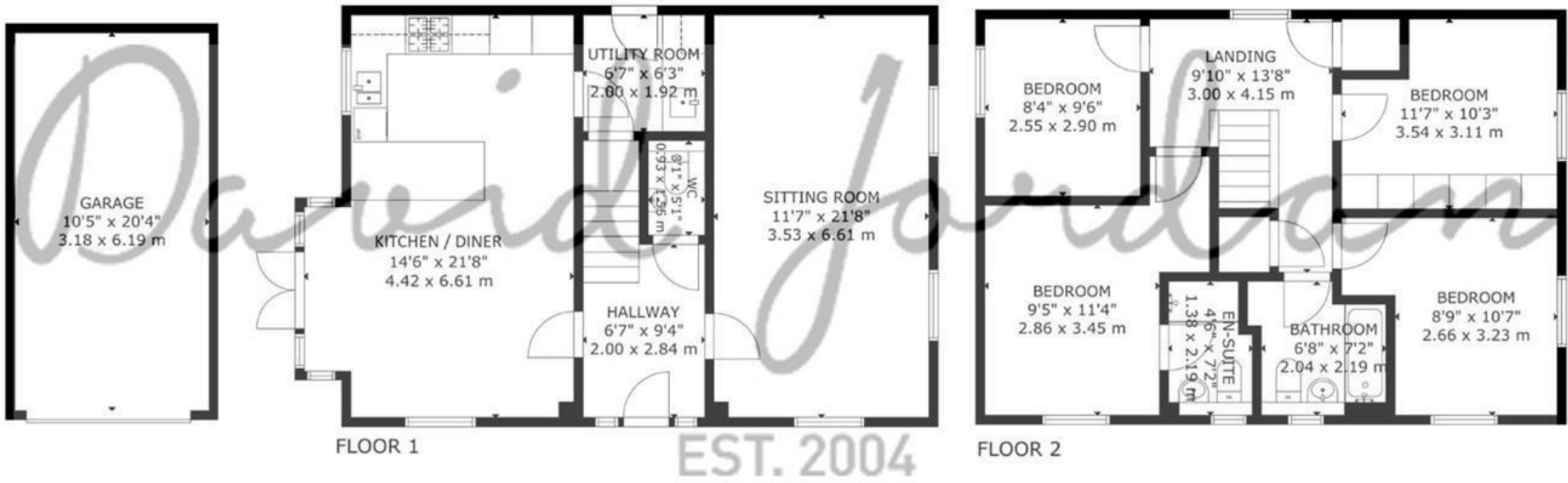
On the first floor are four bedrooms, family bathroom and en-suite shower room to master bedroom.
