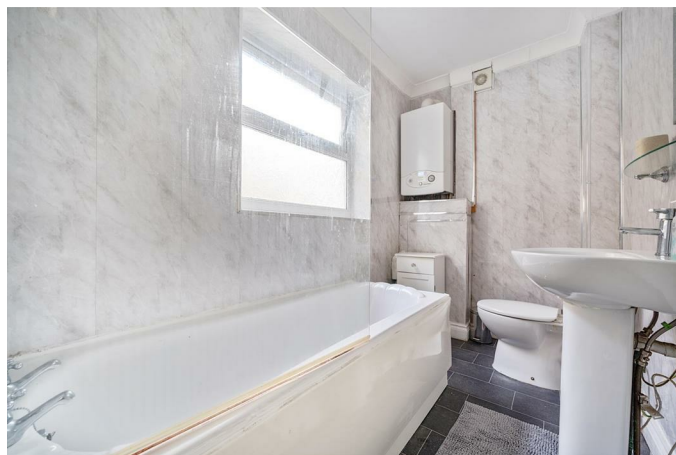

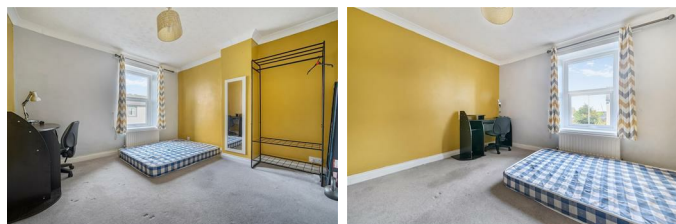

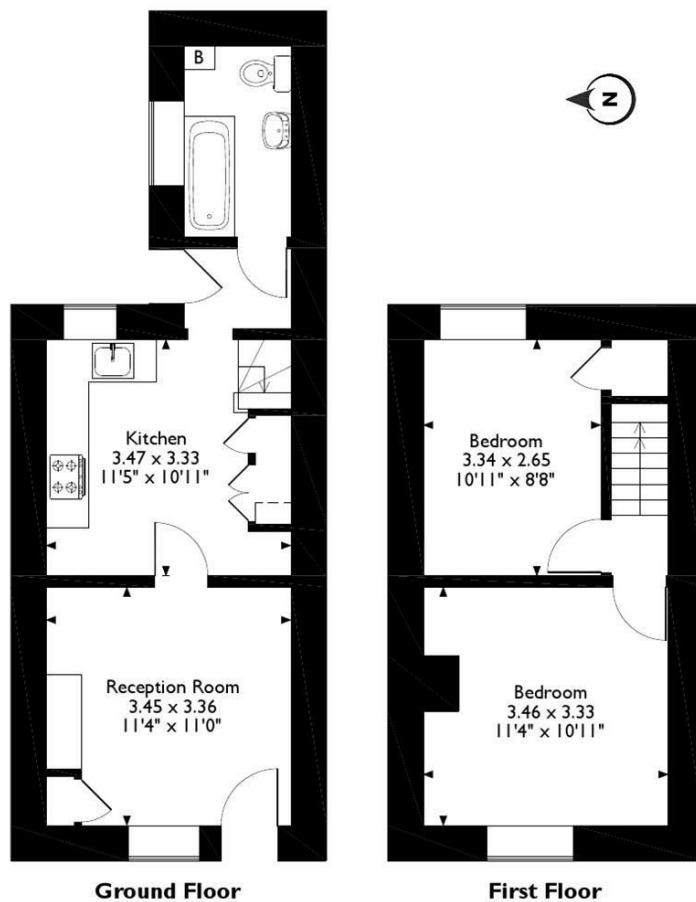

Birks Road, Cleator Moor, Cumbria, CA25 5HS

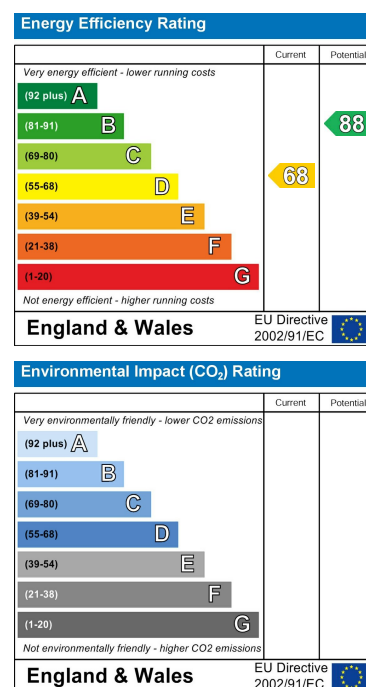
