MORESBY PARKS

Moresby Parks is an attractive village with a strong sense of community situated approximately 3 miles from Whitehaven town centre, well placed for easy access to industries along the west coast including the Sellafield complex. On a wider note, the village is literally only a few minutes drive from the attractions of the Lake District National Park including the lakes and fells around the Ennerdale, Wasdale and Eskdale valleys - some of the finest scenery in England.

The village is close to a number of useful facilities and attractions around Whitehaven including Whitehaven Golf Club, St Benedicts High School, the Whitehaven Academy and the West Cumberland Hospital, all within very easy reach.

The village itself includes a local Primary School, Church and useful Post Office / Convenience Store and nearby Whitehaven offers an attractive harbour area, town centre shopping and easy access to coastal walks including St Bees Head.

THE DEVELOPMENT SITE

The site enjoys direct access from Moresby Parks Road and has Full Planning and Building Regulation Consent for 5 x 4 bedroom detached houses. There are two designs, currently referred to as Type 'A' and Type 'B'. Full elevation and floorplan designs are available.

PLANNING CONSENT

Full Planning and Building Regulation Consents have been granted, including Approval of Conditions, for the Construction of 5 x 4 bedroom Detached Houses. This offers an ideal 'IMMEDIATE START' development opportunity. Planning Consent, Ref: 4/18/2044/0F1 dated 20th December 2018, following which commencement works have been carried out.


