

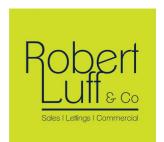

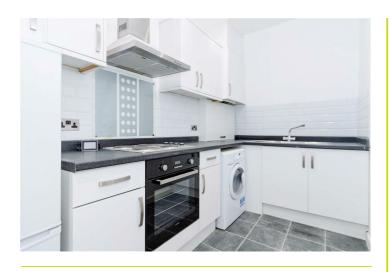

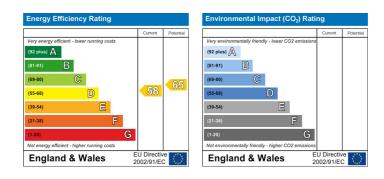




Floor Plan
