Approach

The property is approached via a pathway double glazed front entry door opening into:

Hallway

With double glazed window, central heating radiator, two ceiling light point and stairs giving rise to the first floor apartment.

Open Plan Living and Kitchen Area

17'7" max x 14'4" min x 11'8" max x 8'10" min (5.37 max x 4.37 min x 3.58 max x 2.7 min)

With a double glazed window to the rear aspect, laminate wood effect flooring, two ceiling light points, two central heating radiators, a selection of wall and base units with work surfaces over incorporating one and a half bowl stainless steel sink and drainer with mixer tap over, built-in cooker with four ring burner gas hob with extractor over, space for washing machine, door opening into storage cupboard and doors opening into:

Bedroom One

17'8" max 14'4" min x 8'5" max x 5'4" min (5.4 max 4.38 min x 2.57 max x 1.64 min)

With three double glazed windows to the front and side aspects, ceiling light point, central heating radiator, loft access point and doors opening into useful storage cupboard.

Bedroom Two

12'10" x 10'9" (3.92 x 3.29)

With double glazed window to the rear aspect, ceiling light point and central heating radiator.

Bathroom

7'4" x 5'8" (2.25 x 1.75)

With a three piece bathroom suite comprising push

button low flush WC, panel bath with hot and cold taps with shower over, sink on pedestal with two taps over, tiling to splash backs, ceiling light point, ceiling extractor and central heating radiator.

Outside

One allocated parking space.

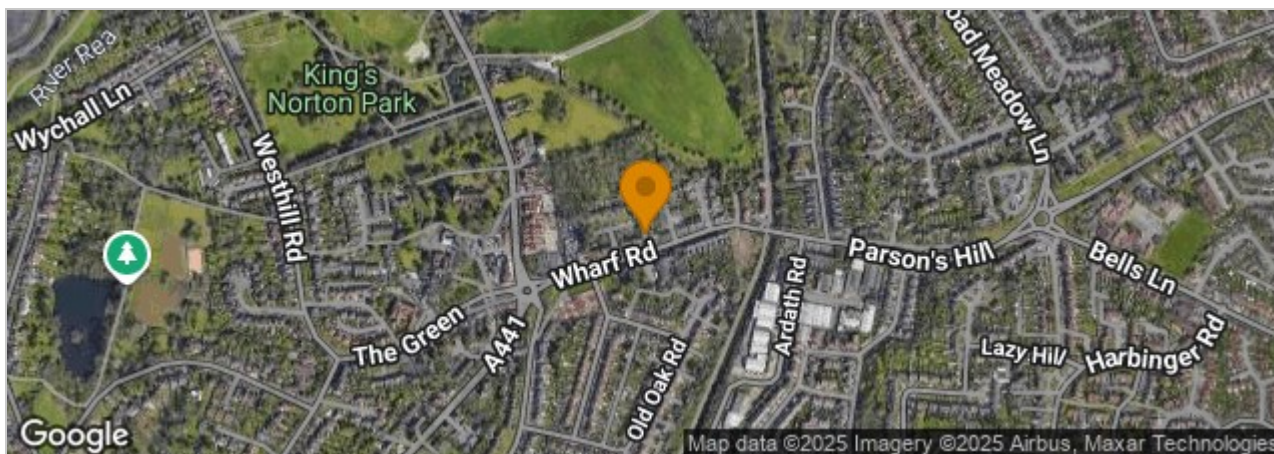
Council Tax

Tenure

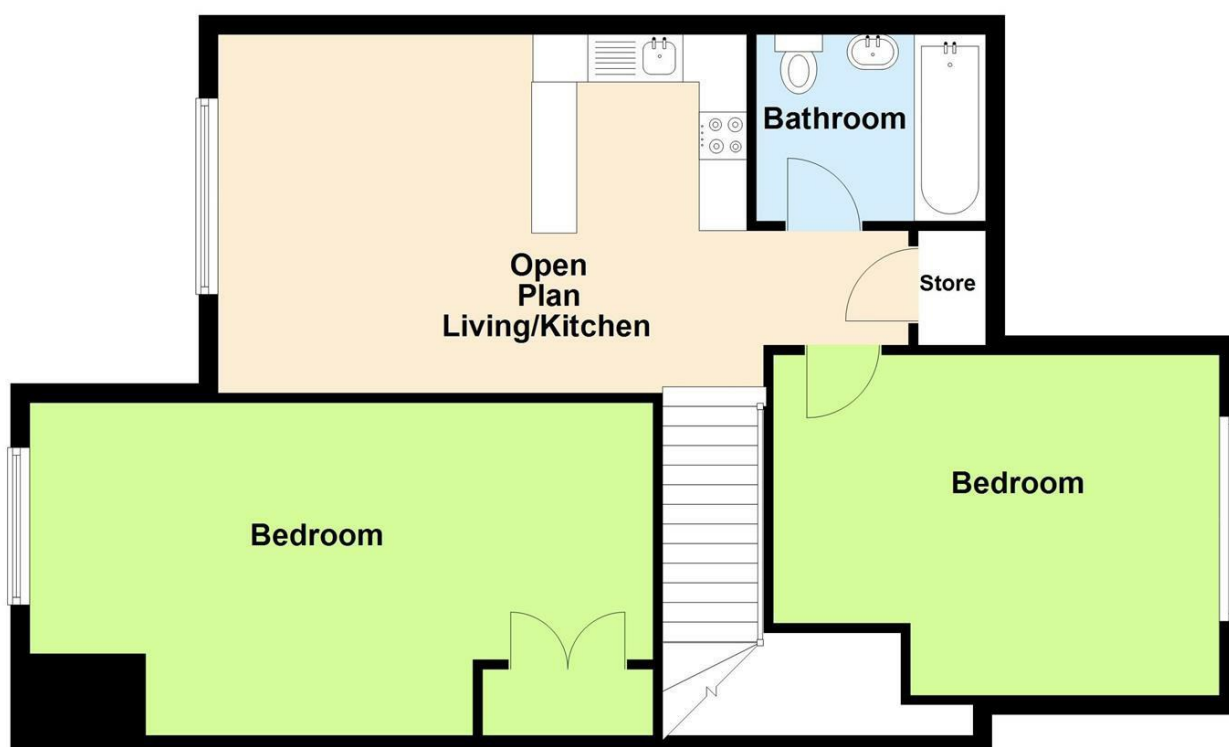

Floor Plan

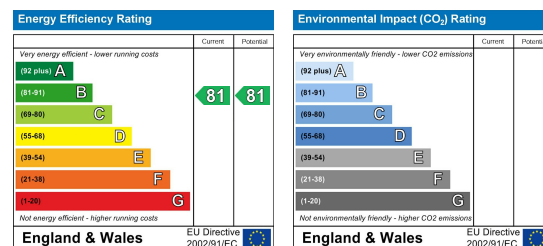
Kings Close- NOT TO SCALE - For illustrative purposes only
