With a selection of wall and base units with wood effect work surfaces over incorporating sink and drainer with mixer tap, space for fridge freezer, washer/dryer and dishwasher, built-in cooker and hob with extractor over, laminate wood effect flooring, ceiling light point and tiling to splash backs.

With laminate wood effect flooring, double glazed bay window to the rear aspect and two ceiling light points.

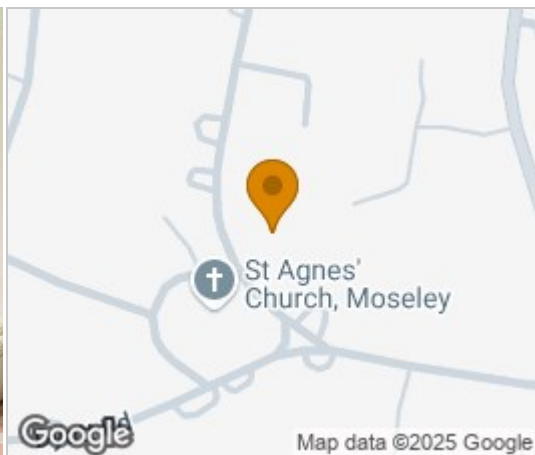
Council Tax Band

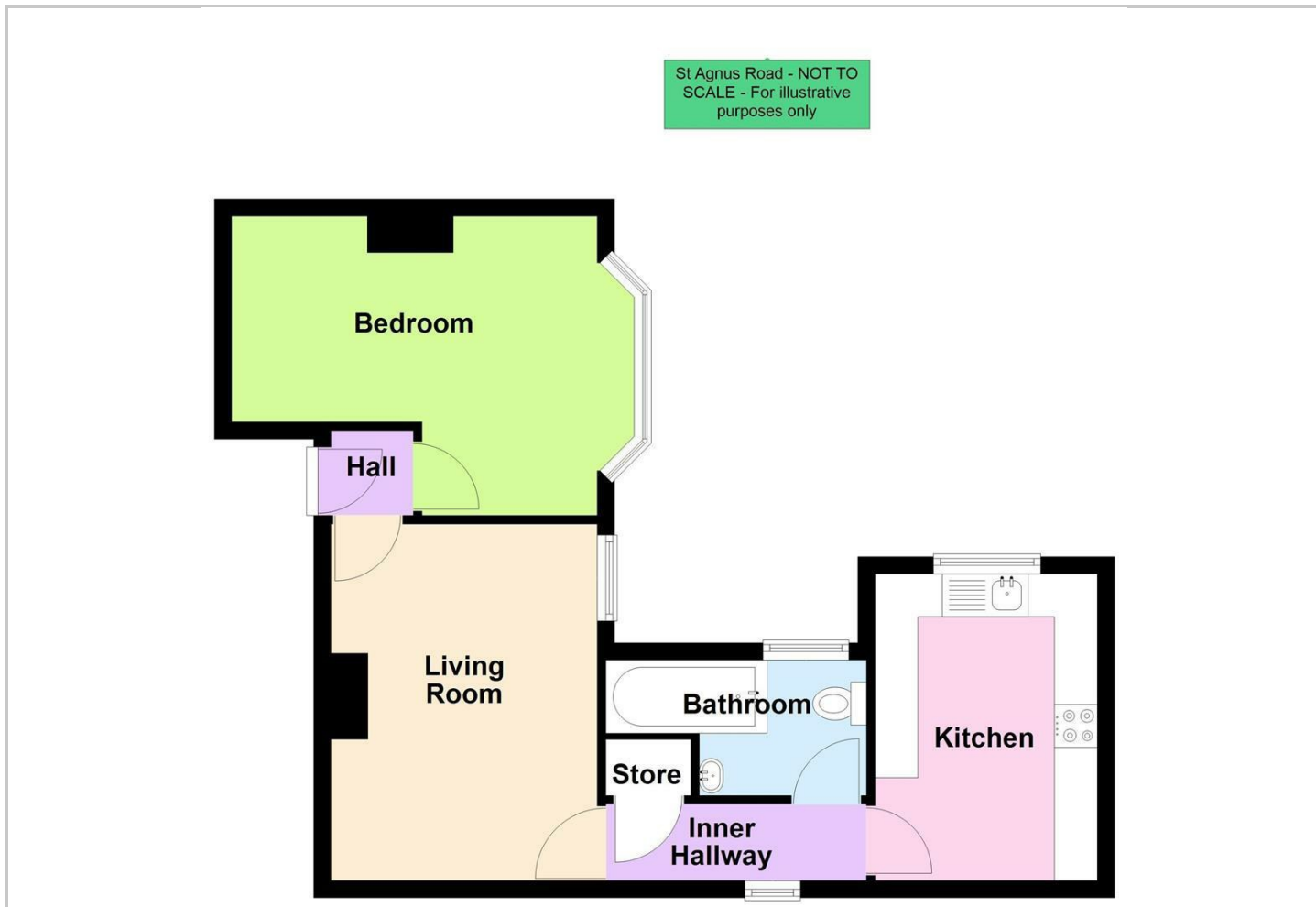
Tenure

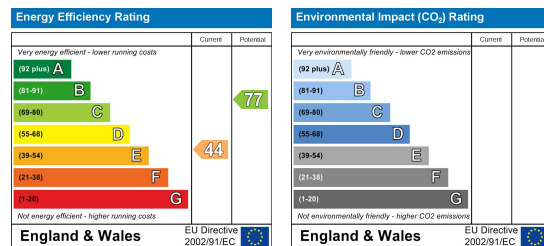
Floor Plan
