Approach

The property is approached via a paved pathway with lawn turfed areas leading to a secure front entry door opening into communal hallway with stairs giving rise to the top floor accommodation with door opening into:

With ceiling light point, central heating radiator, laminate wood effect flooring, door opening into storage cupboard with n-built shelving, wall mounted intercom system and doors opening into:

Living Room

With two ceiling light points, electric fireplace, central heating radiator, double glazed windows overlooking the communal gardens and beautiful Jasmin Fields and continued laminate effect flooring.

Kitchen

With continued laminate wood effect flooring, double glazed window to the rear aspect, ceiling spotlights, wall and base units with work surfaces over incorporating sink and drainer with hot and cold mixer tap, tiled splash backs, four ring burner gas hob with extractor over, in-built cooker, space for washing machine and fridge freezer and wall mounted Gloworm boiler.

Bathroom

With ceiling spotlights, wood effect lino to flooring, tiled walls, low flush WC, sink on pedestal with hot and cold taps, bath with hot and cold mixer with shower over and extractor fan.

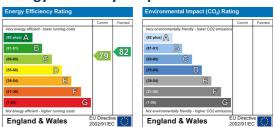
Floor Plan
