This three bedroom semi-detached home tucked away in a popular cul-de-sac within the sought after village of Great Glen represents an ideal opportunity for first-time buyers or investors. Well presented, but with scope for light modernisation presents chance to put your own stamp on this home.

ACCOMMODATION

You step into the entrance hall as you come through the front door which offers access for a handy guest cloakroom to the side. From here is the sitting room which feels spacious and welcoming. A gas fire provides a focal point while the stairs rise to the first floor in the corner. An open archway leads into the dining room at the rear which overlooks the garden beyond and has plenty of natural light coming through the double doors.

The kitchen is equipped with a range of fitted wall and base units providing plenty of storage. There is an integrated oven and gas hob with plumbing and space for washing machine and space for fridge/freezer. A pantry cupboard makes use of the space under the stairs while a door to the side provides outside access to the drive.

Upstairs the main bedroom is situated at the front and features fitted wardrobes and cupboards. There are two further bedrooms and the bathroom has been re-fitted as a shower room which features shower cubicle, WC and wash hand basin.

OUTSIDE

The front is gravelled providing an attractive low-maintenance space with hard-standing drive to the side providing off-road parking for two vehicles. The rear garden has been landscaped and features a paved patio terrace, lawn with bedding borders and timber framed shed.

SERVICES: The property is offered to the market with all mains services and gas-fired central heating.

Great Glen is located approximately seven and a half miles south east of Leicester city centre, a popular village with an abundance of local amenities including village store, popular pubs, parish church, local primary school, post office, hairdressers and GP surgery.

DIRECTIONAL NOTE




From Market Harborough town centre proceed north along the A6 towards Leicester, through the village of Kibworth. At the Archers roundabout on the A6 bypass turn right towards Great Glen and left at the T-junction. Turn right into Church Road. At the mini-roundabout proceed straight into Oaks Road and turn right into Cherry Grove where the property can be found on the right hand side.
