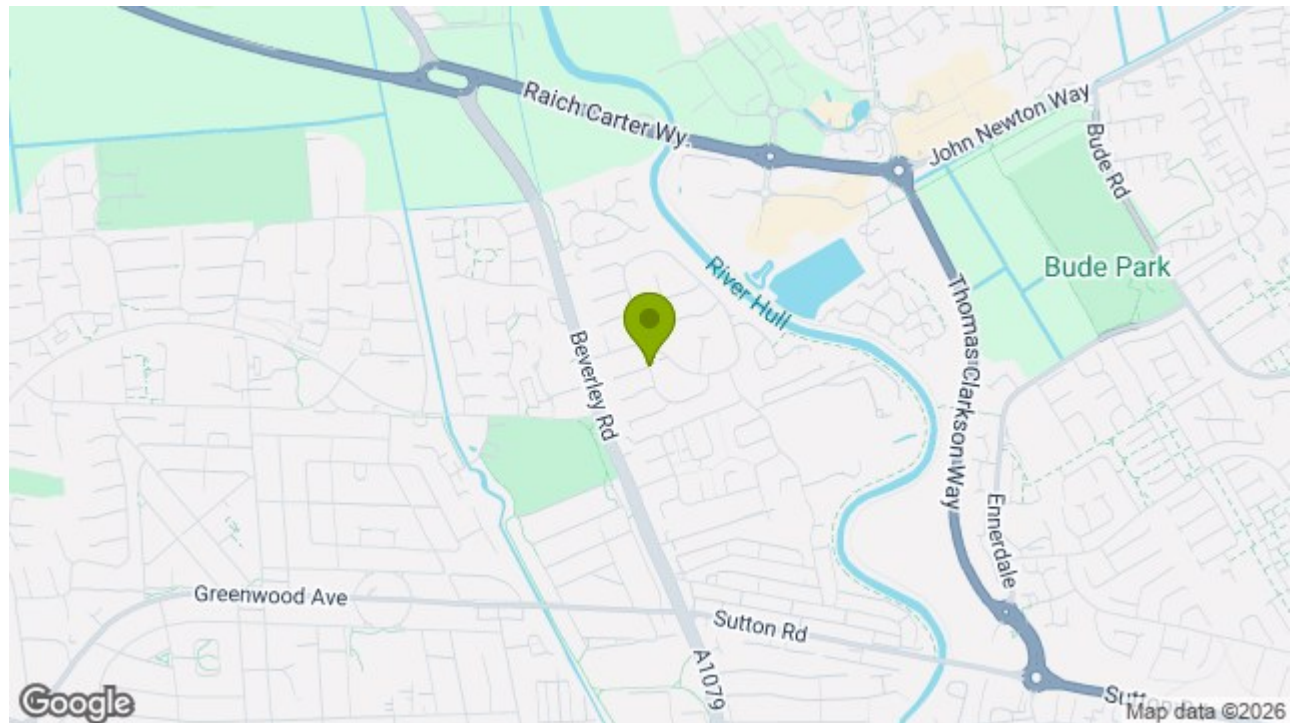

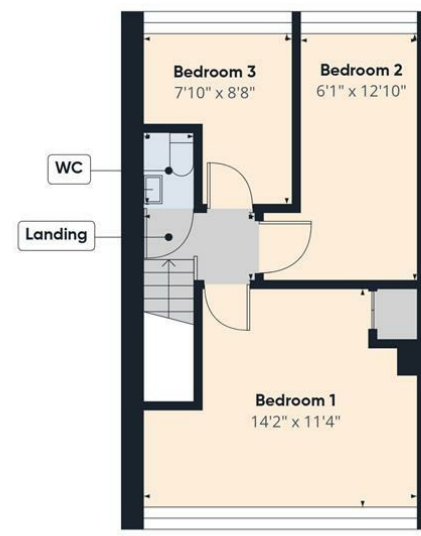




Ground Floor
