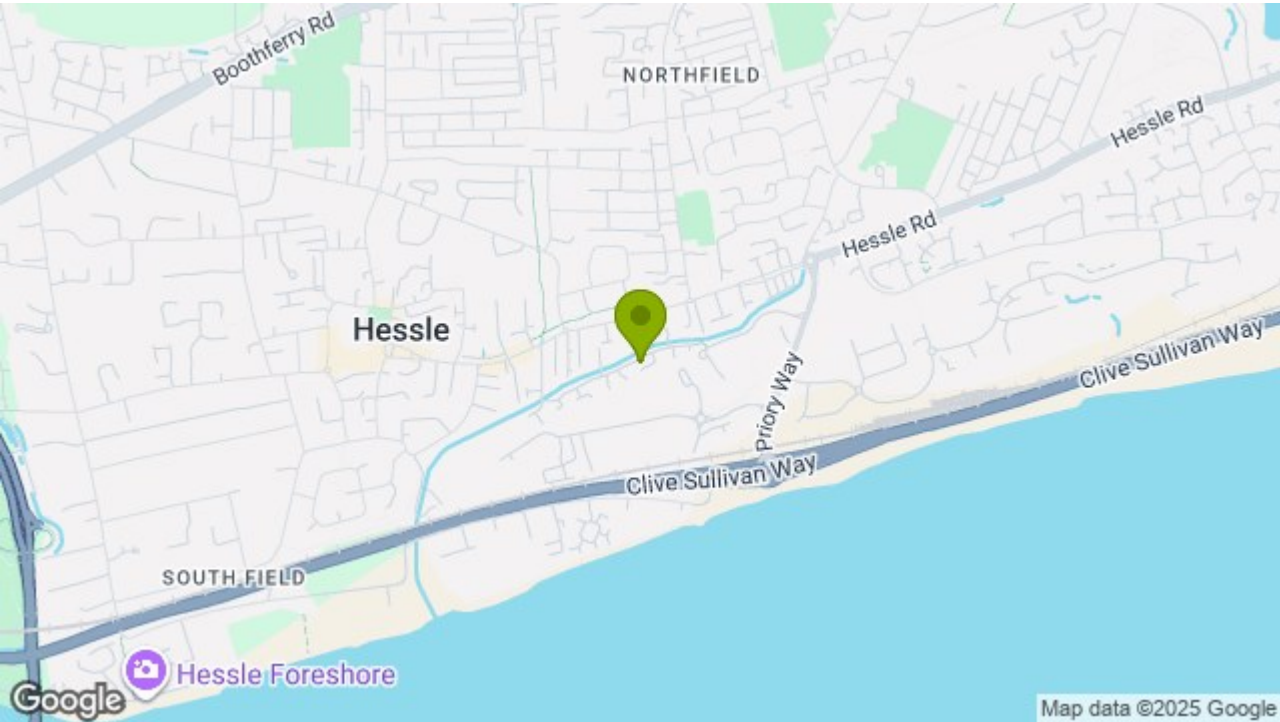

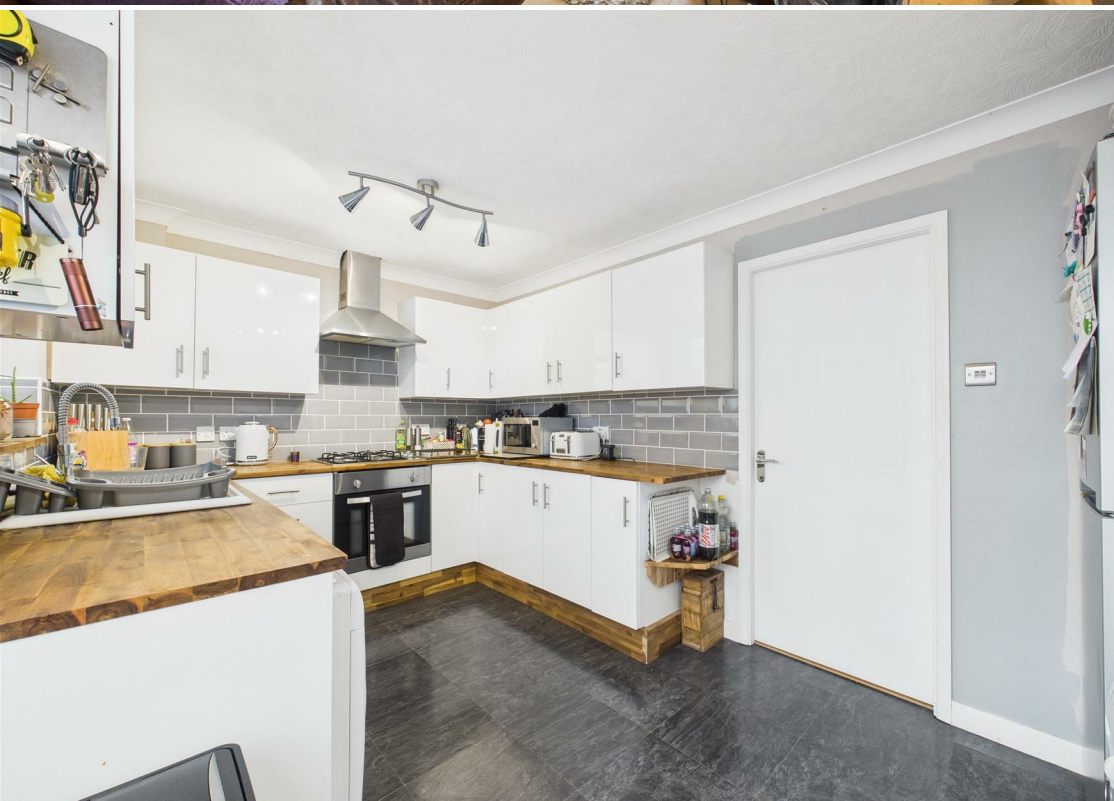

HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. Good road and rail connections are available with a local train station off Southfield, and the A63 dual carriageway running nearby to the South of the town, allowing convenient access to Hull City Centre and the national motorway network.

GROUND FLOOR;

ENTRANCE HALL

A welcoming entrance hall with stairs off.

LIVING ROOM

A generous living room with laminate wood flooring, feature wall with brick-slips, windows to the front and side elevations and access to the storage cupboard.

KITCHEN

With white gloss wall and base units, solid wooden work surfaces and a tiled splashback. Integrated appliances include a Gas Hob, Electric Oven and an Extractor Fan. Further benefitting from space for a Fridge/Freezer, plumbing for both an Automatic Washing Machine and a Slimline Dishwasher. Also benefitting from a breakfast bar, French doors leading to the conservatory and a window to the rear elevation.

CONSERVATORY

A great addition to the property providing versatile reception space with windows to the side and rear elevation, French doors leading to the garden.

A bedroom of double proportions with fitted wardrobe, laminate wood flooring and a window to the front elevation.

BEDROOM 2

A generous bedroom with fitted sliding wardrobe, laminate wood flooring and a window to the rear elevation.

BEDROOM 3

A single bedroom with fitted sliding wardrobe, laminate wood flooring and a window to the rear elevation.

With a three piece suite comprising of a panelled bath with overhead shower, a low flush WC and a vanity wash hand basin. Further benefitting from tiled walls, a heated towel rail and a window to the side elevation.

Well presented frontage with slate chippings, footpath and wrought iron gate with fencing. Side drive providing off-street parking for vehicles.
