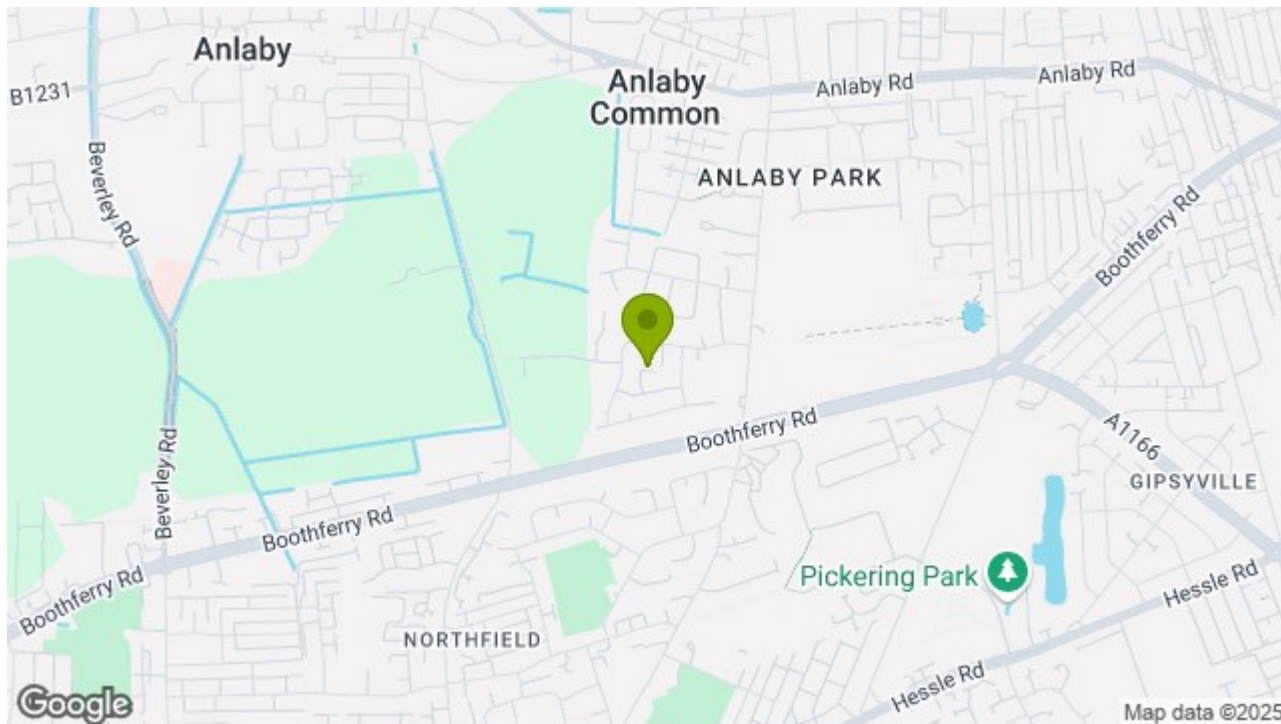

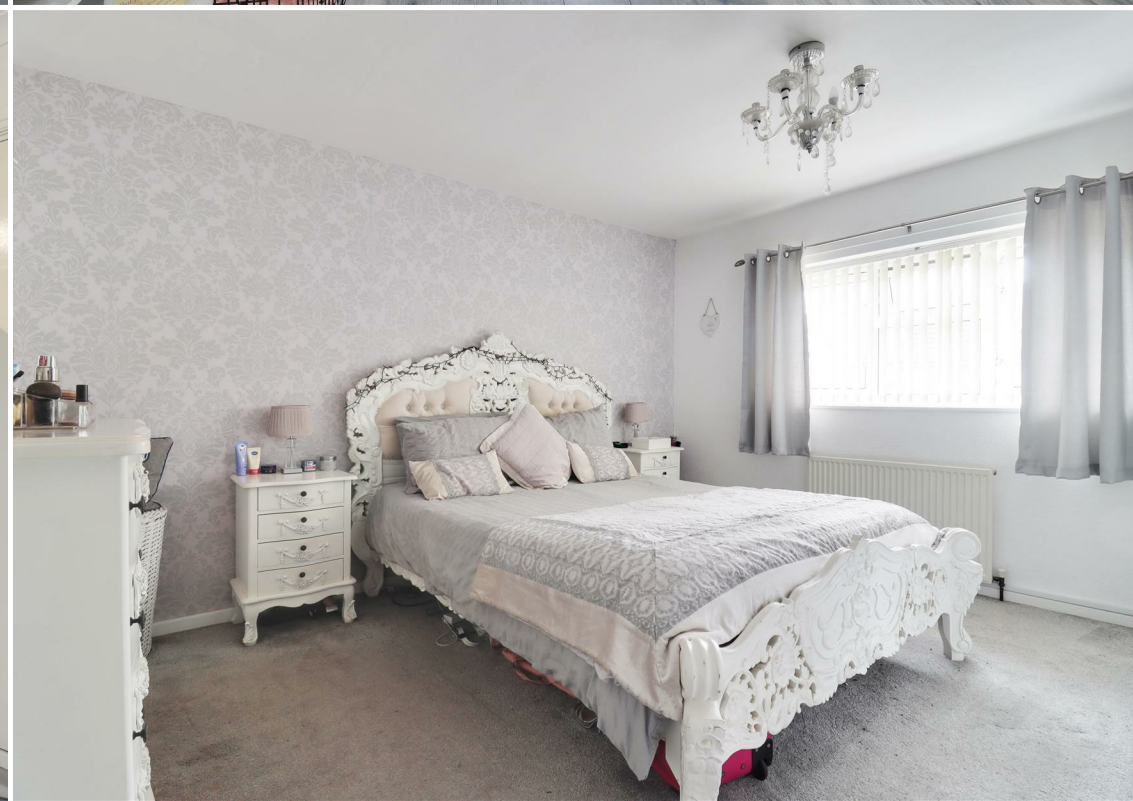

## GROUND FLOOR;

### ENTRANCE HALL

Pleasant entrance hall providing access to the accommodation and stairs off.

### KITCHEN

9'11 x 8'4 (3.02m x 2.54m )

With grey gloss wall and base units, laminated work surfaces and splashbacks. Integrated appliances include a Gas Hob, Electric Oven, Extractor Fan and a Sink with further plumbing for an Automatic Dishwasher and a window to the rear elevation.

### LIVING / DINING ROOM

23'6 x 11'6 max (7.16m x 3.51m max)

A generous reception space with ample room for both living and dining, benefitting from laminate wood flooring, a feature fireplace, window to the front elevation and French doors to the rear elevation.

A bedroom of double proportions with a storage cupboard and window to the rear elevation.

### SHOWER ROOM

Contemporary shower room with a three piece suite comprising of a walk in shower and a vanity unit housing a WC and a wash hand basin. Further benefitting from a heated towel rail and a window to the side elevation.

Front garden laid mainly to gravel with hedged borders.

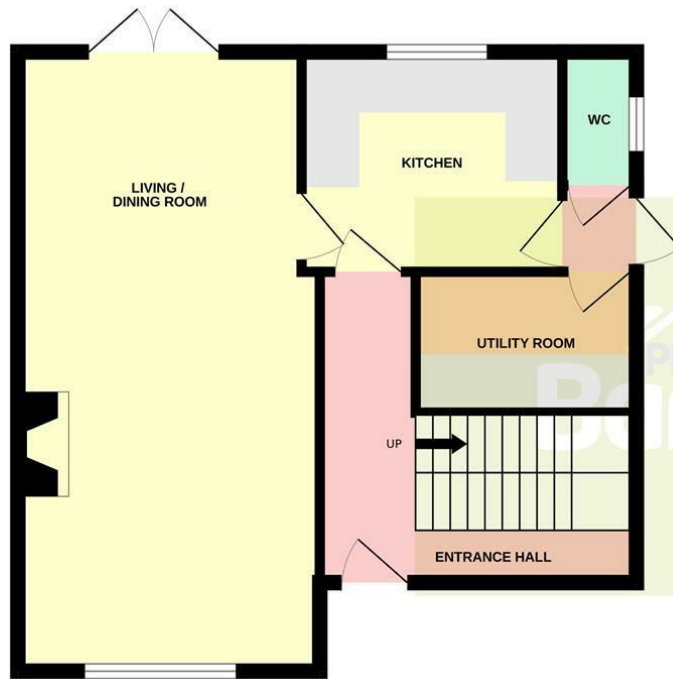
