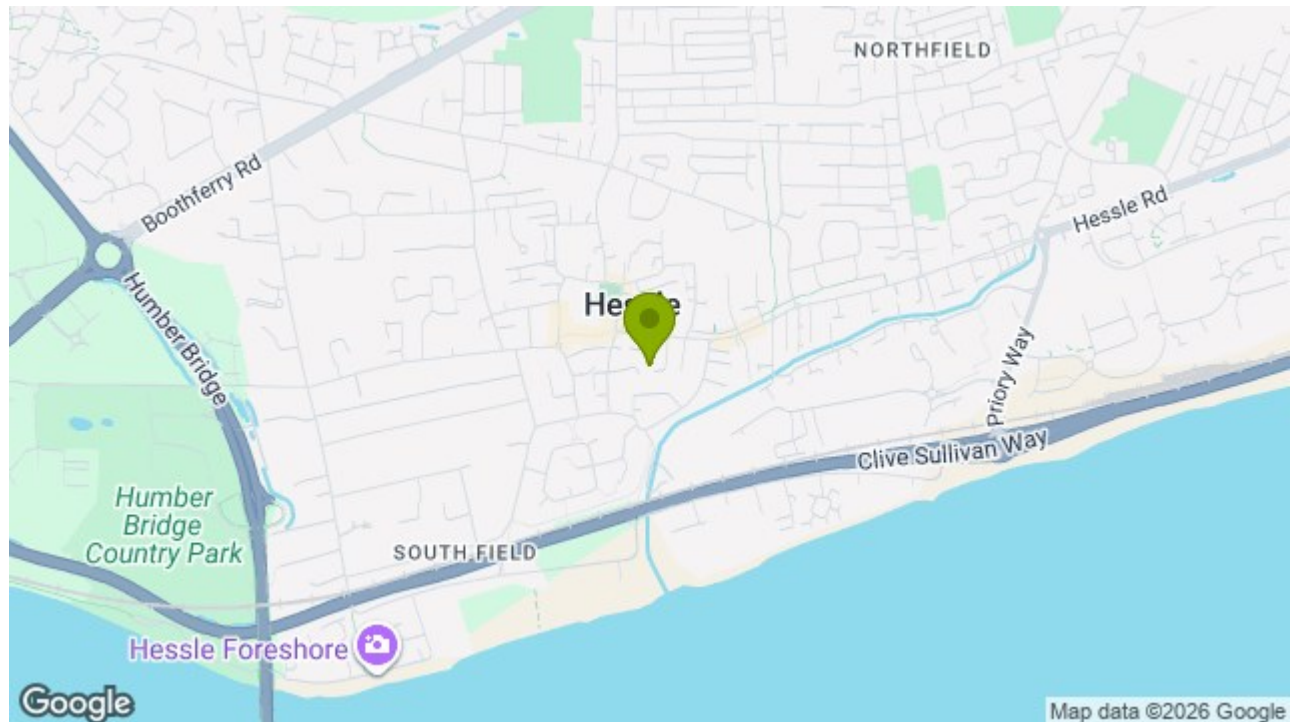

HESSLE

The Town of Hesse is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. Good road and rail connections are available with a local train station off Southfield, and the A63 dual carriageway running nearby to the South of the town, allowing convenient access to Hull City Centre and the national motorway network.

GROUND FLOOR;

ENTRANCE HALL

Providing access to the accommodation with stairs off.

LIVING ROOM

A generous living room with a bay window to the front elevation and recessed spotlights.

DINING KITCHEN

An open plan dining kitchen with cream gloss wall and base units, laminated work surfaces and a breakfast bar. Integrated appliances include a Gas Hob, Electric Oven and an Extractor with plumbing for an Automatic Washing Machine. The space also benefits from French doors to the rear garden, ample dining/living space and recessed spotlights.

FIRST FLOOR;

BEDROOM 1

A bedroom of double proportions with a bay window to the front elevation and recessed spotlights.

BEDROOM 2

A further double bedroom with window to the rear elevation and recessed spotlights.

BEDROOM 3

A generous single bedroom with window to the front elevation.

BATHROOM

With a three piece suite comprising of a panelled bath with overhead shower, a low flush WC and a wash hand basin. Further benefitting from tiled walls, radiator, recessed spotlights and a window to the rear elevation.

EXTERNAL;

FRONT

A gravelled frontage providing off-street parking. A shared side drive leads to the garage.

REAR

Generous rear garden laid mainly to lawn with timber fencing.

GARAGE

Detached garage providing ample storage space.

GENERAL INFORMATION

SERVICES - Mains water, electricity, gas and drainage are connected to the property.

CENTRAL HEATING - The property has the benefit of a gas fired central heating system to panelled radiators.

DOUBLE GLAZING - The property has the benefit of replacement PVC double glazed frames.

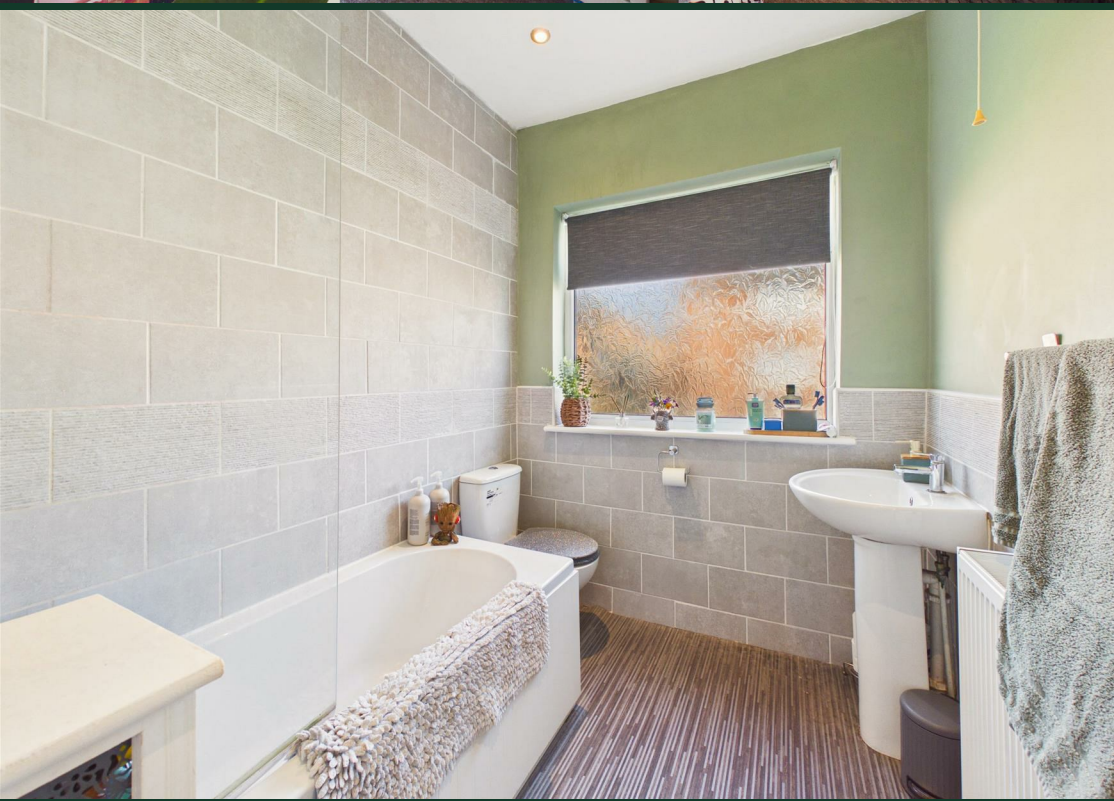

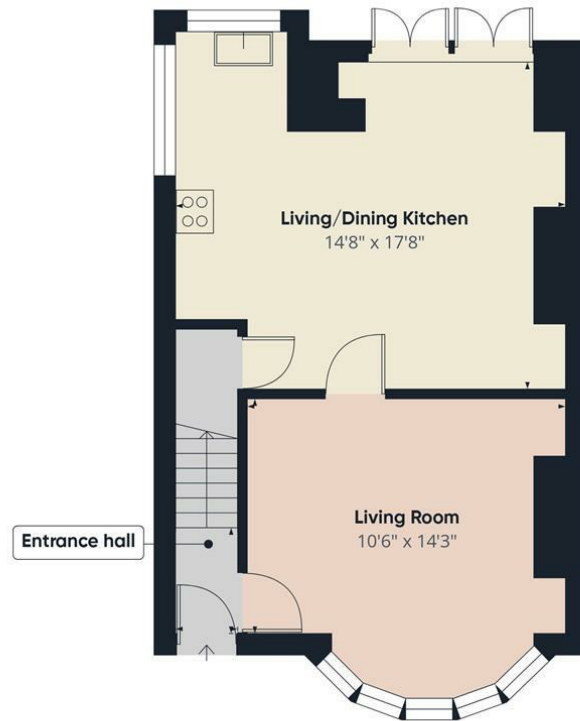
