A superb three-bedroom home, conveniently situated on the sought-after west side of Hessle and within easy reach of the excellent range of amenities that Hessle town has to offer.

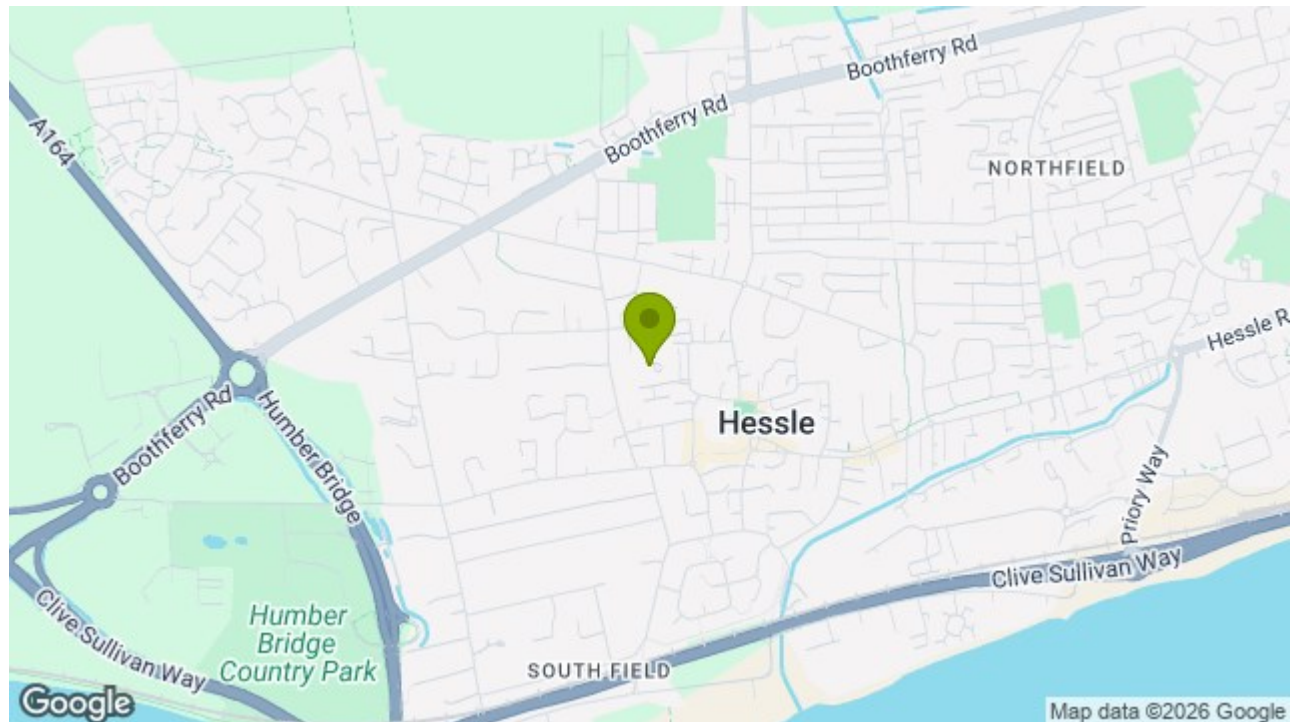

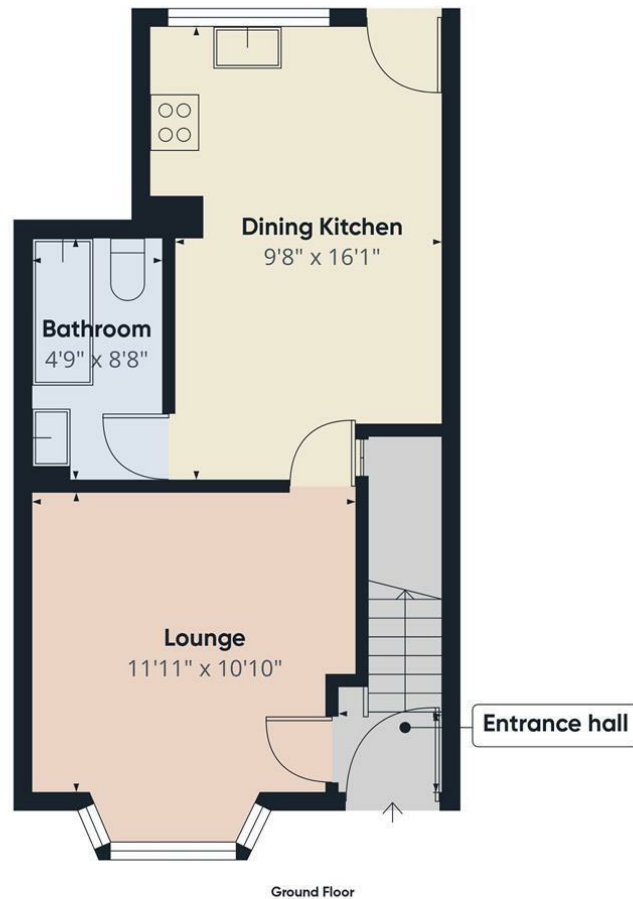
TENURE.
