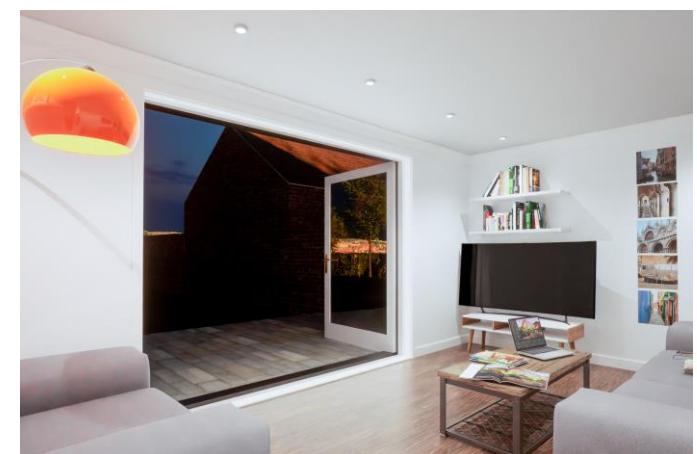

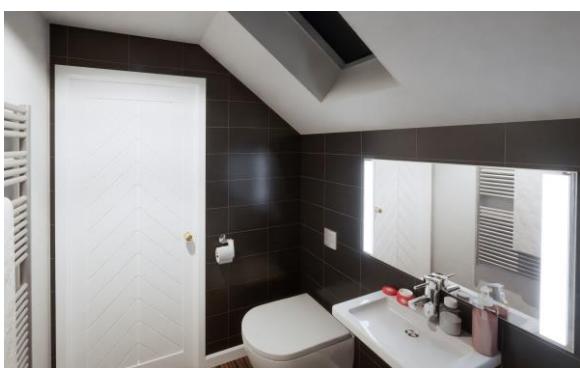
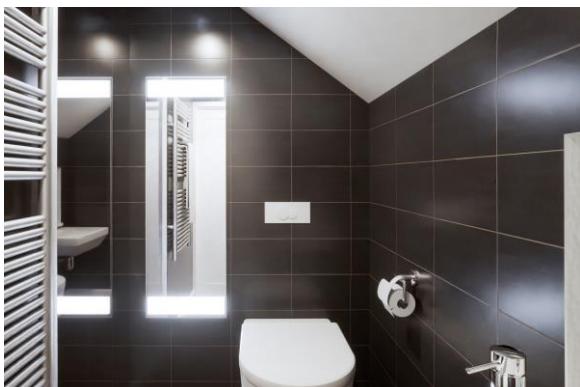
The barn will feature double glazed casement windows and air source central heating system providing a combination of underfloor heating (ground floor only) and radiator heating on the first floor. The property will also come with a Structural Completion Certificate.

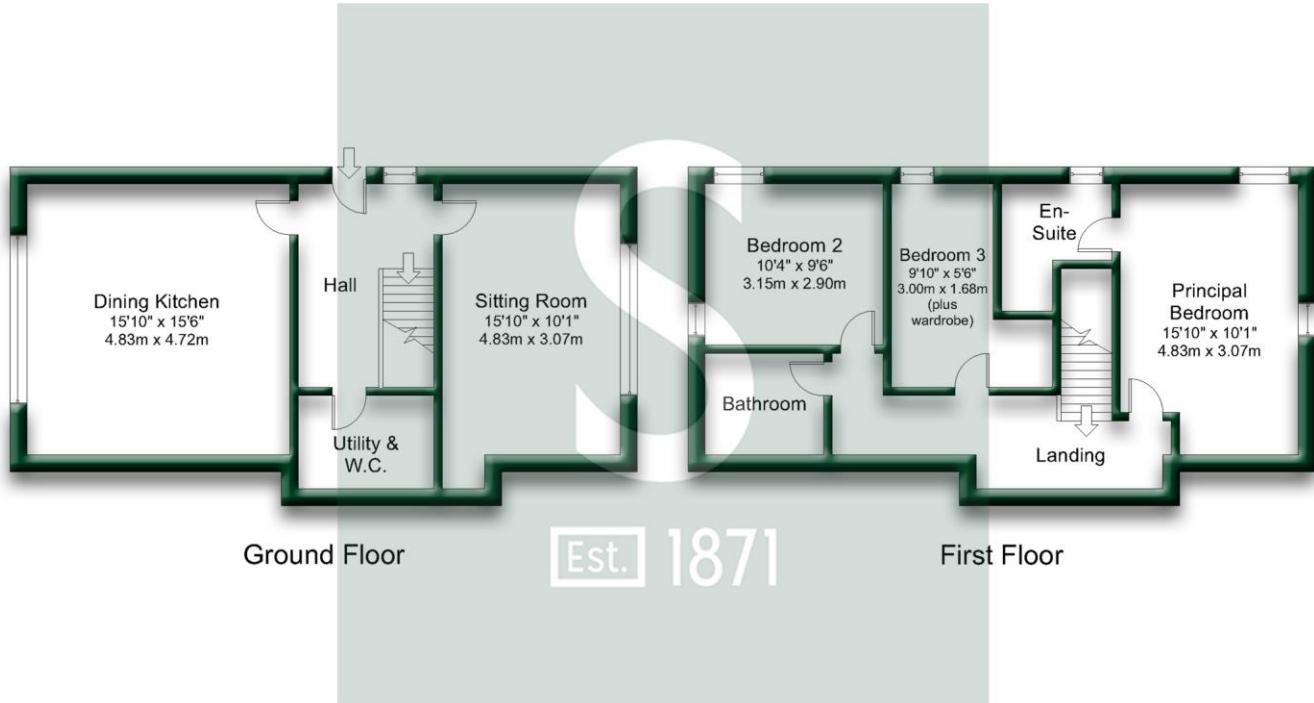
