



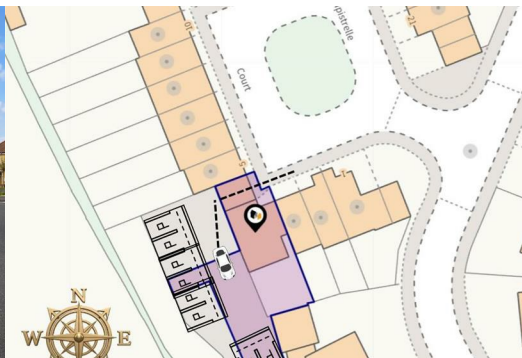

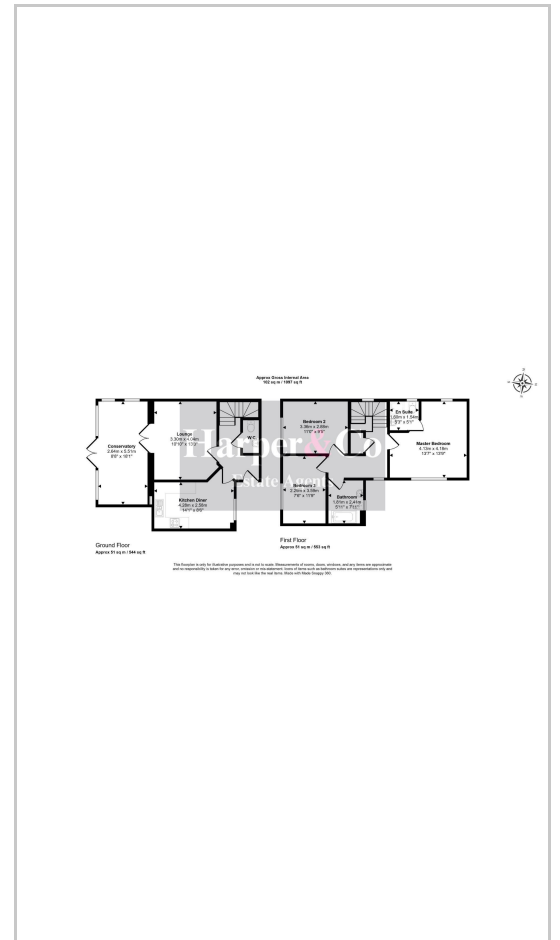

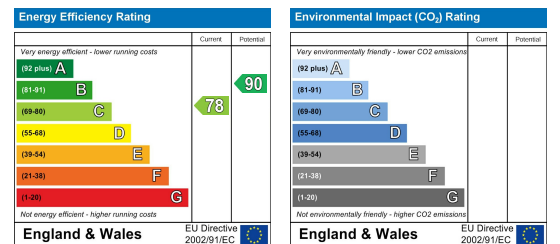
Area Map
