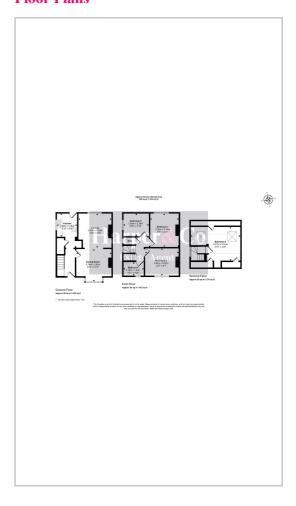

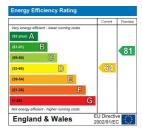
Area Map

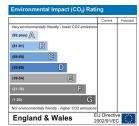


Floor Plans
