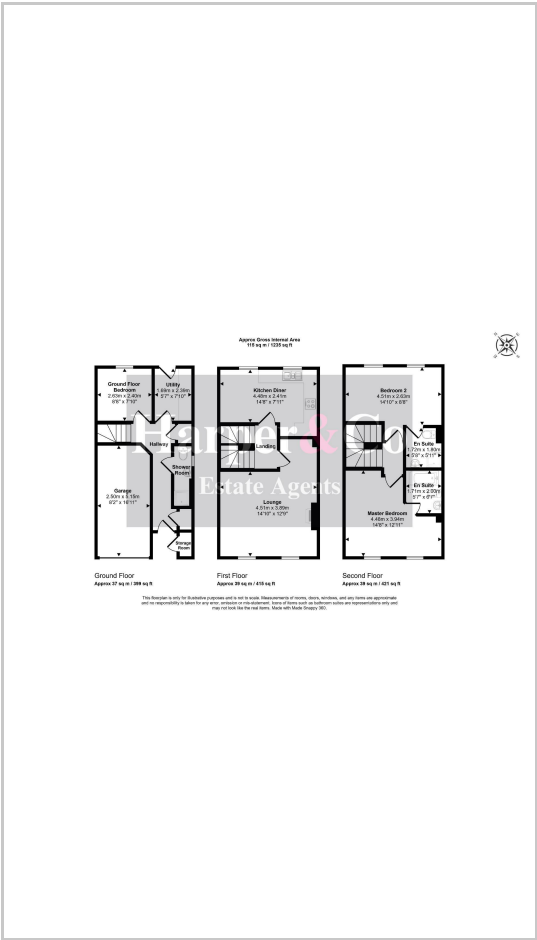

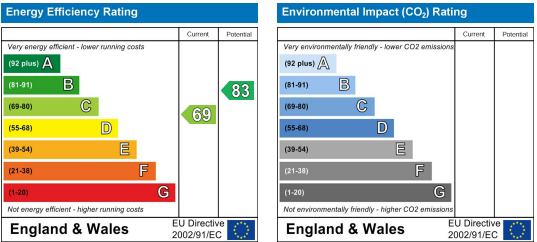
Area Map
