



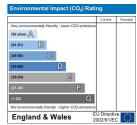


### Floor Plans
