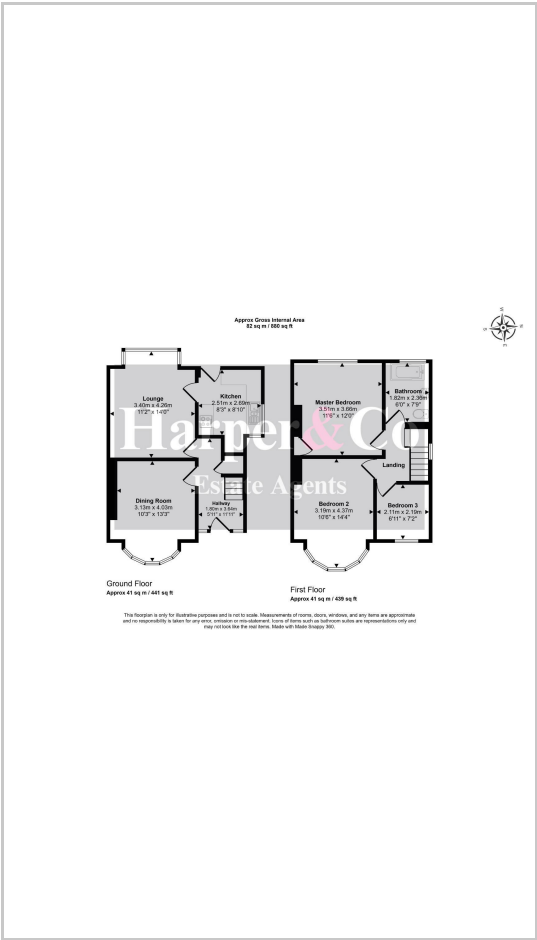

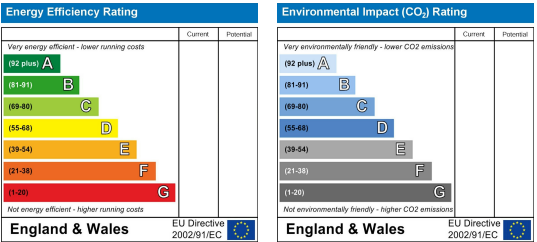
Area Map
