Located on the goldings development near the edge of Newquay, the property is in close proximity to the popular residential and commercial area of Treloggan which benefits from amenities such as a public house, McDonalds the Prow Park business village as well as and major supermarkets plus being a short walk to the glorious Trenance Valley with its Newquay Zoo, Waterworld, The Boating Lake, Trenance Gardens, Heron Tennis Centre and the Bowling Green.

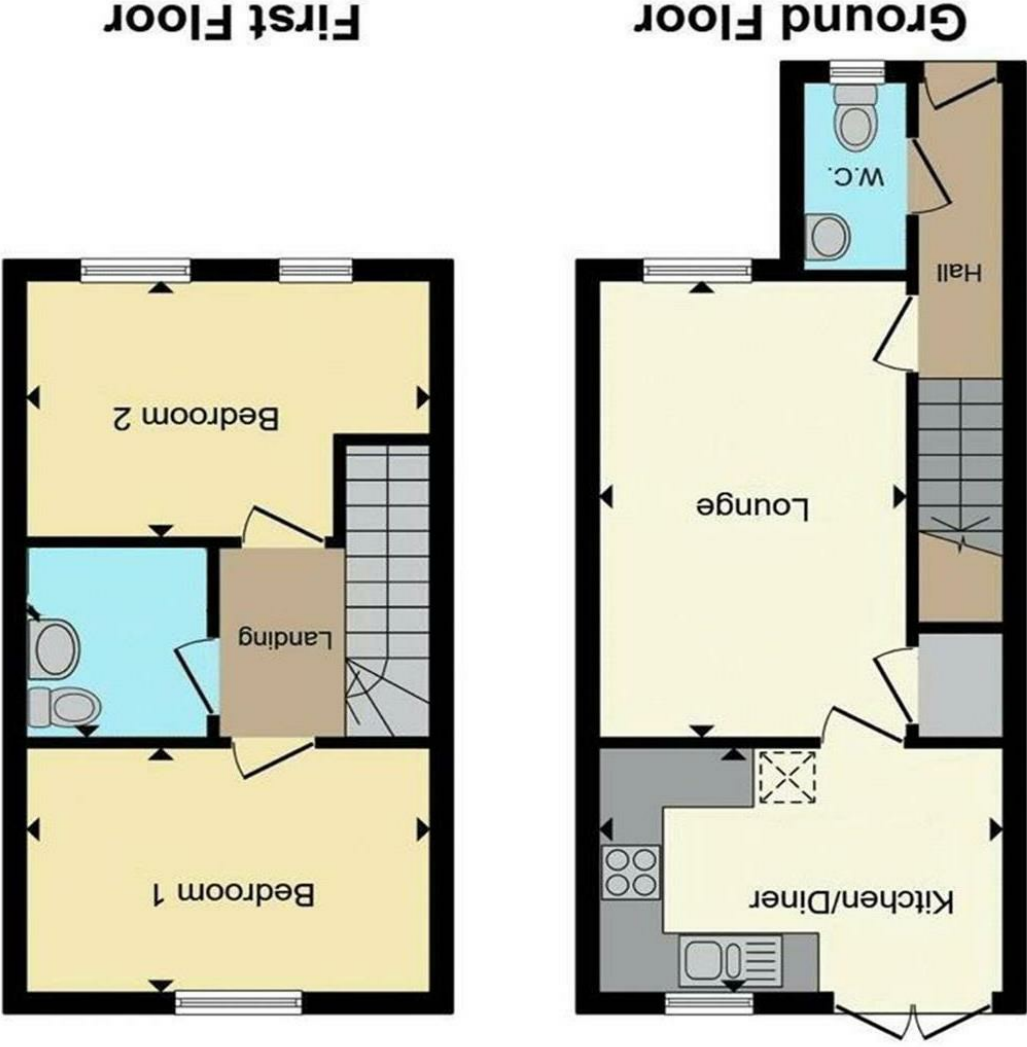
EXTERIOR
