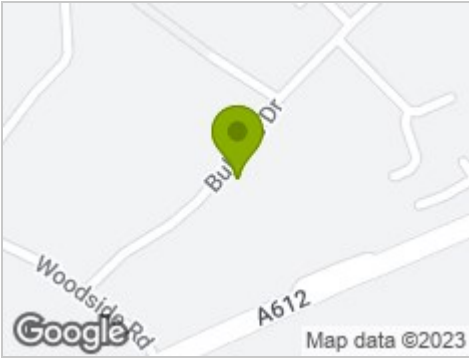

Road Map



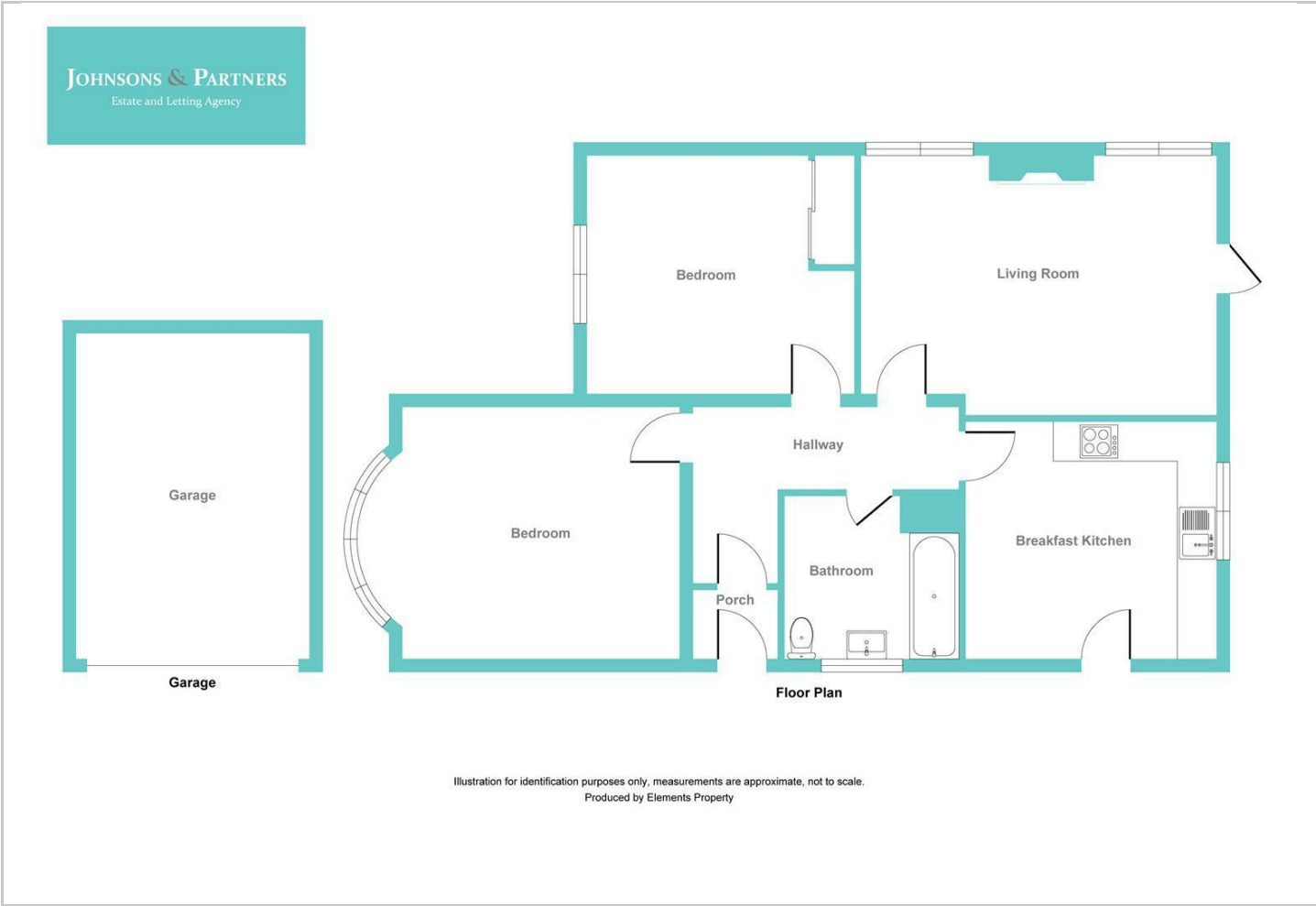
Hybrid Map



Terrain Map



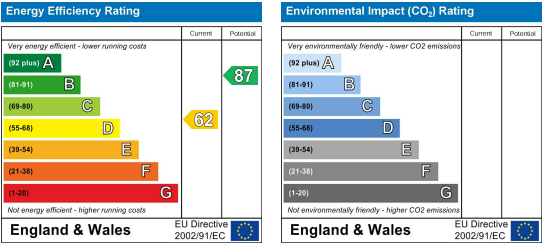
Floor Plan
