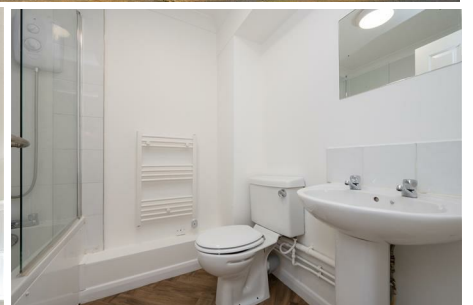

The well proportioned and smartly presented accommodation is arranged on the ground floor to provide a generous sitting room, a stylish contemporary kitchen incorporating the dining area, and a cloakroom. The first floor comprises three bedrooms and a bathroom.

### LOCATION

St Peters Cottages are based in a highly desirable location within the town's sought after conservation area in central Whitstable and easily accessible to shops, bus routes and station. Whitstable is an increasingly popular and fashionable town by the sea offering a good range of amenities including an array of café bars, independent shops, highly regarded restaurants, watersports facilities and working harbour. The mainline railway station is just moments away, providing fast and frequent links to London (Victoria) approximately 80 mins. The high speed Javelin service provides access to London (St Pancras) with a journey time of approximately 73 mins. The A299 is accessible providing a dual carriageway link to the M2/A2 giving access to the channel ports and connecting motorway network.

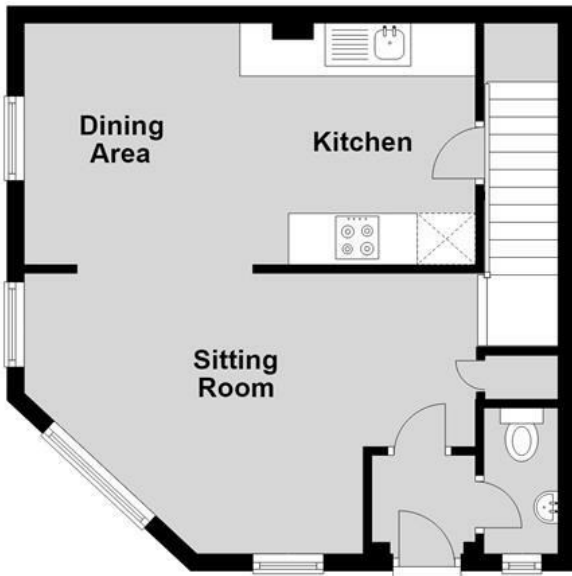

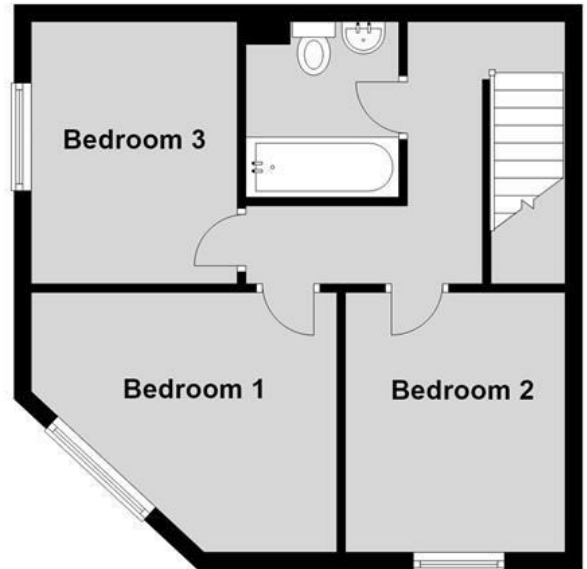
