A staircase leads to the first floor, and the room is fitted with two radiators.

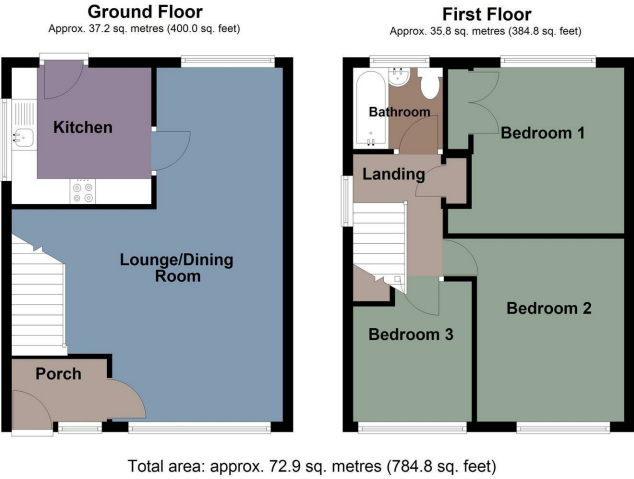

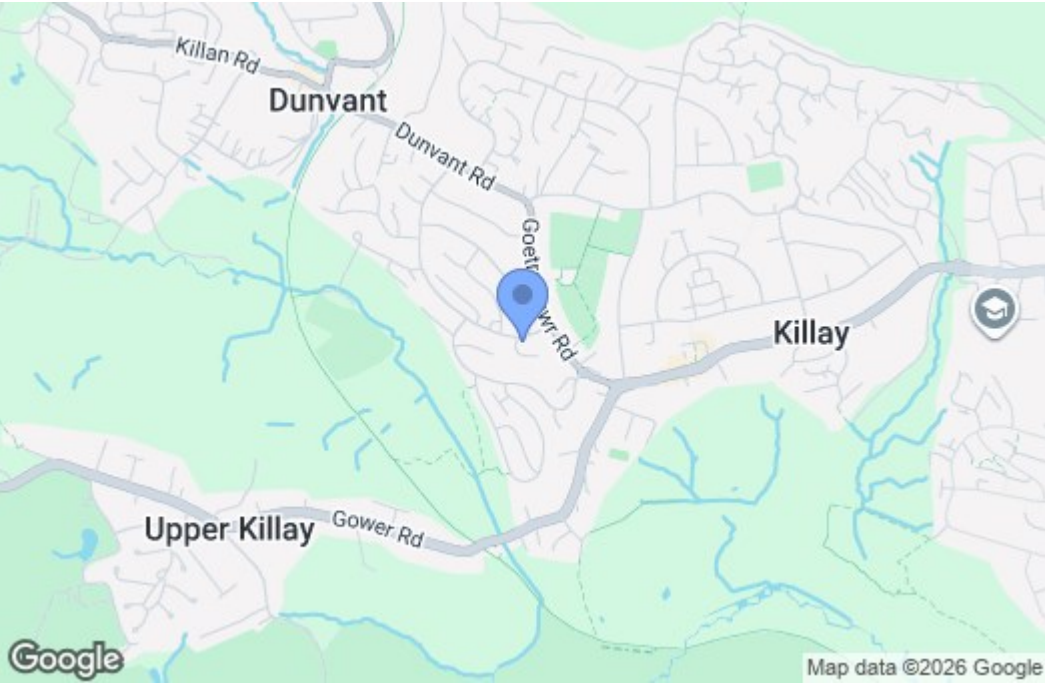

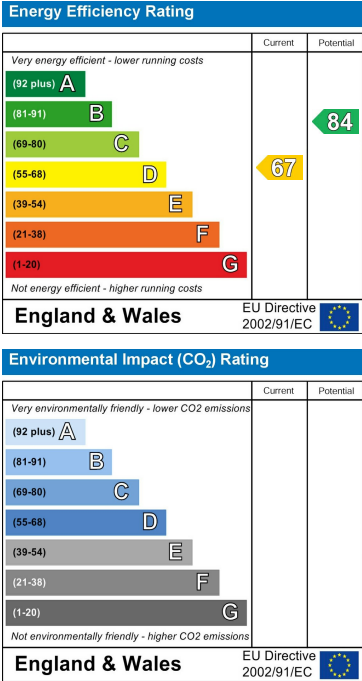
Floor Plan
