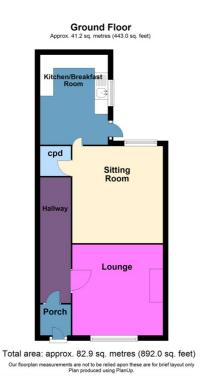

#### **Floor Plan**

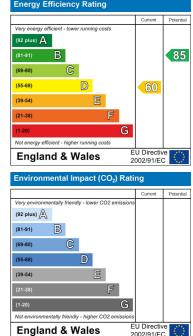




#### **Area Map**
