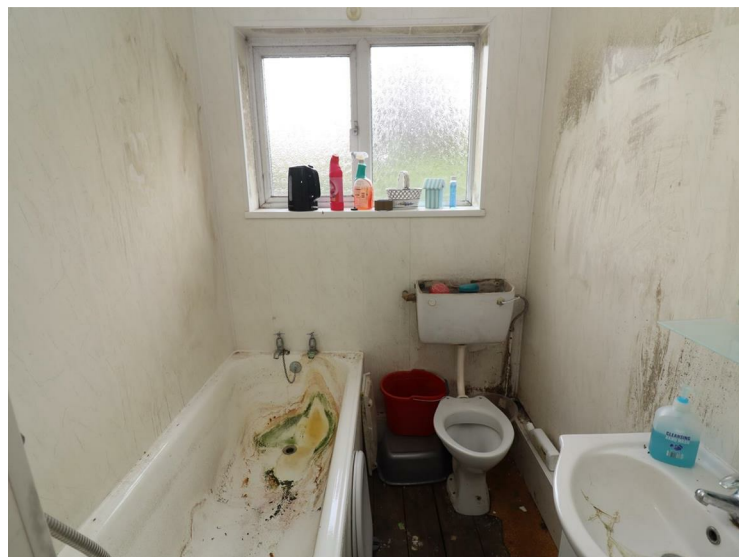

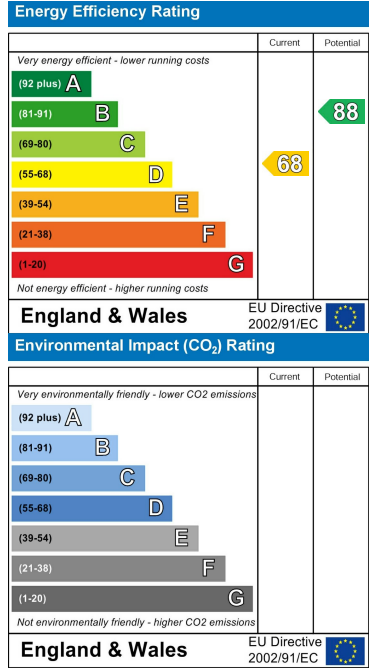
Floor Plan
