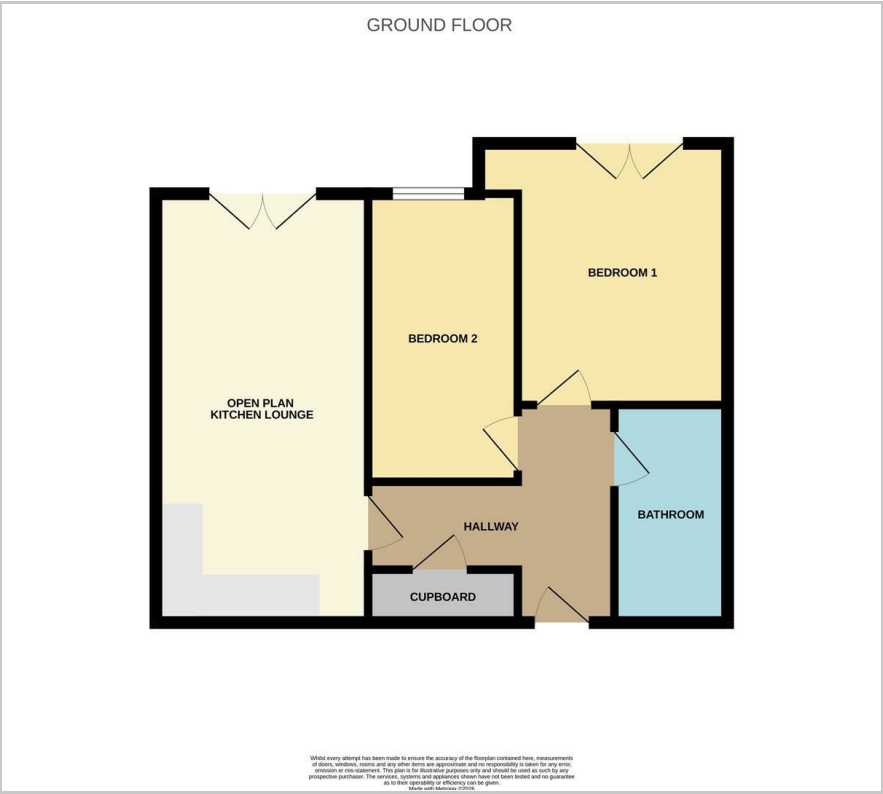

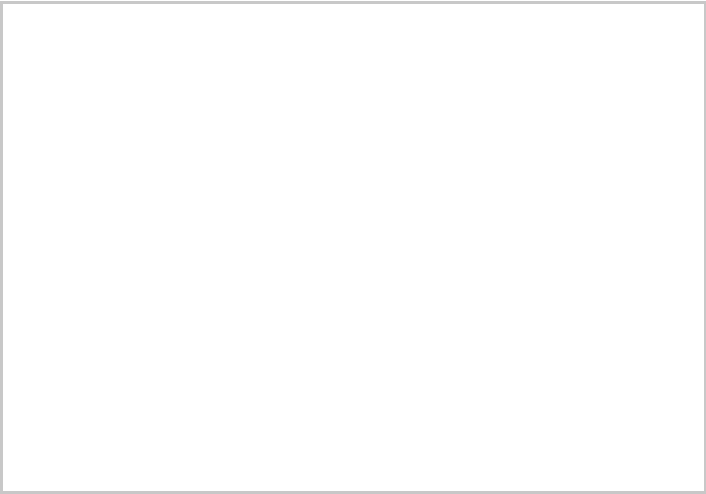
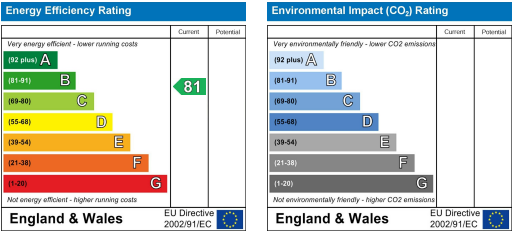
Floor Plan
