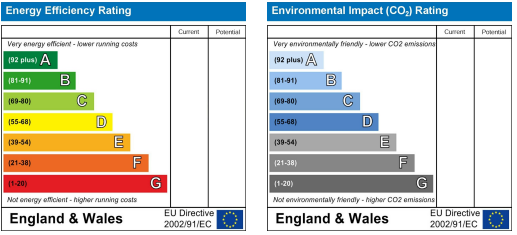
Floor Plan
