

****FOR SALE WITH NO UPWARD CHAIN**SET ON A CORNER PLOT**** This EXTENDED DETACHED BUNGALOW comprises of ENTRANCE PORCH, LOUNGE having feature fireplace, KITCHEN with a range of fitted wall, base & drawer units, Integrated electric Oven & gas Hob, extractor over, Integrated Fridge, space provision for further appliances including a full height Fridge Freezer, UTILITY ROOM/REAR PORCH, with plumbing and space for a Washing Machine & Dryer, door out to the side of the property, INNER HALLWAY, BEDROOM THREE (currently used as a DINING ROOM) with UPVC French doors leading into the CONSERVATORY, which has French doors leading to the rear garden, BEDROOM ONE with an impressive range of fitted wardrobes, STUDY leading into BEDROOM TWO, with wardrobes, SHOWER ROOM with double shower cubicle, rainfall shower, white suite of wash hand basin & WC inset into fitted unit, full height heated chrome towel rail.

Externally, the property is accessed via double wrought iron gates, providing access to the block paved driveway, there is a lawn, which continues to the side of the property, where there is full height pedestrian gate giving access to the REAR GARDEN, which is of low maintenance having Indian Stone & block paved patio area, decking area, space for a shed. At the side of the property there is a dropped kerb and access could be made for additional parking if required.

Meir Heath has its own Post Office, General Stores, Pub/Restaurants, Takeaway & Hairdressers, recreation areas with Grindley Park being a short walk. Easily accessible commuter links & bus routes, highly regarded schools with Meir Park amenities and Blythe Bridge with its own Railway Station being only a short drive away. In addition there is Grindley Park being just a short walk, as is Rough Close Common.


Floor Plans


