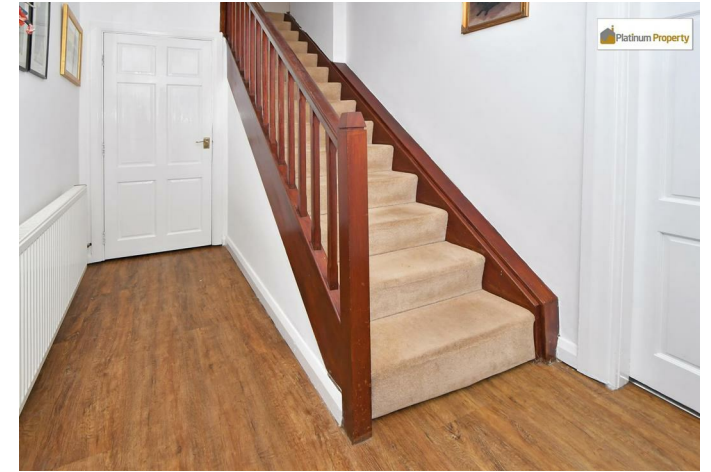

Location Map

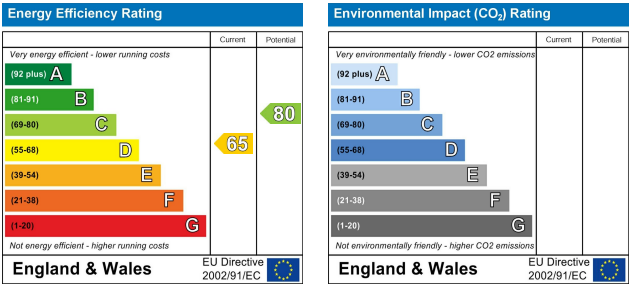
