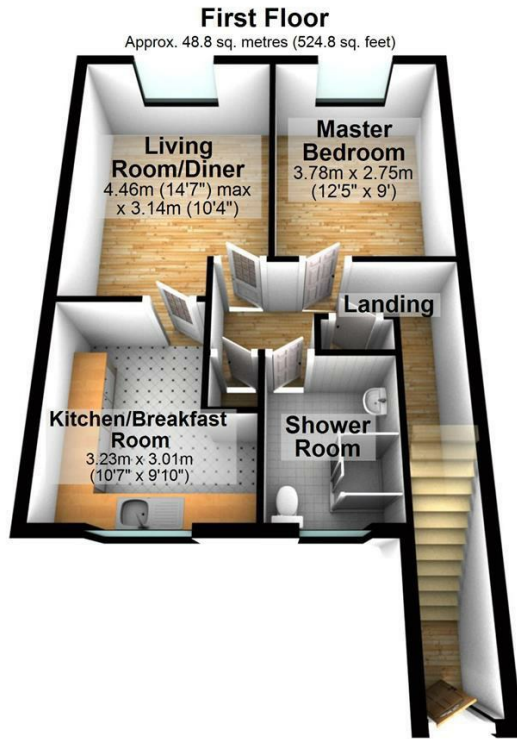

## Floor Plan

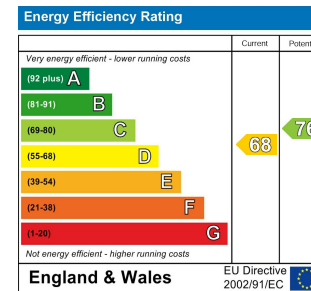
