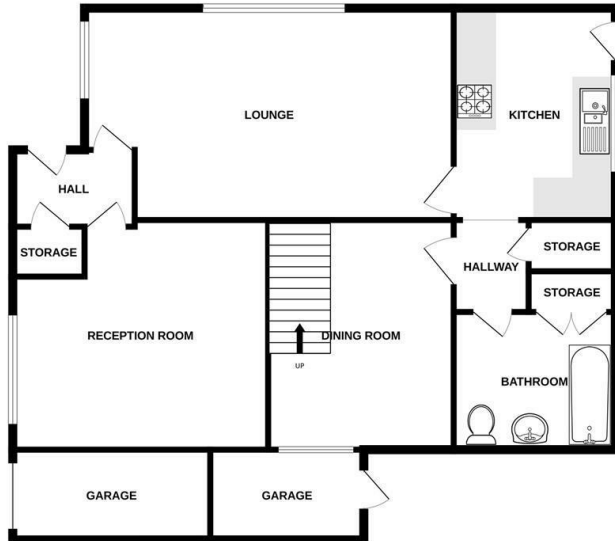

Upstairs, the chalet continues to impress with four comfortable bedrooms, making it ideal for growing families or those needing extra space along with a W/C.

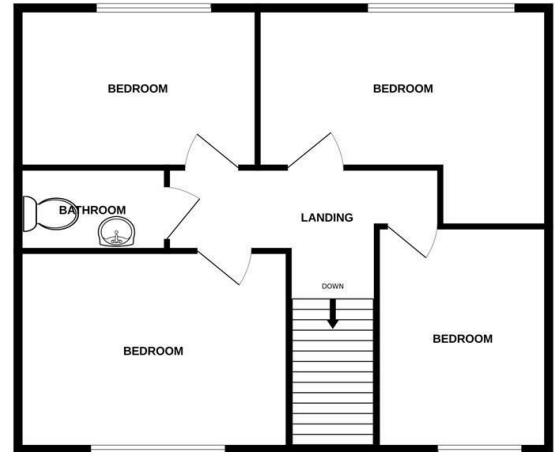

GROUND FLOOR

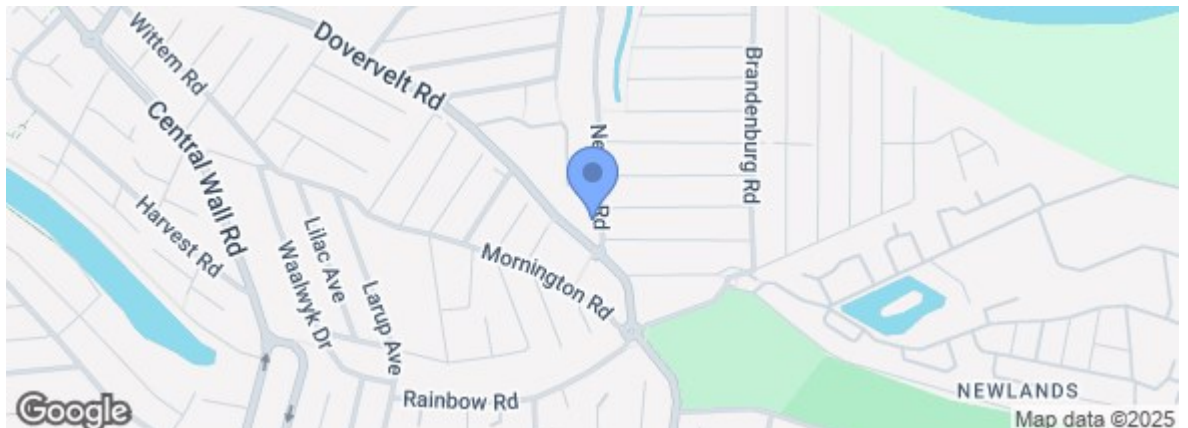


1ST FLOOR
