The accommodation further comprises two well-proportioned bedrooms, a contemporary bathroom suite, a central hallway, and convenient built-in storage.

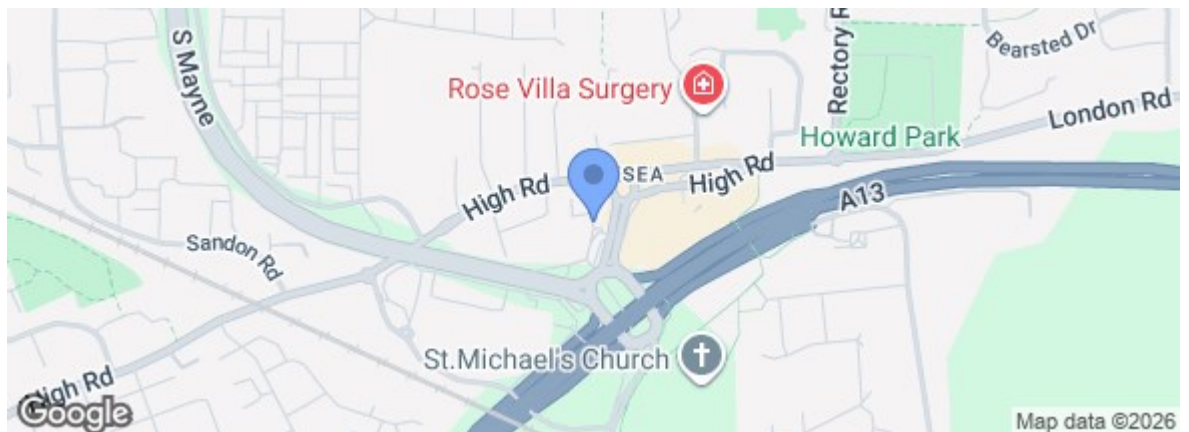
Additional benefits include lift access, an allocated parking space, and a well-maintained development, ensuring both comfort and convenience.
