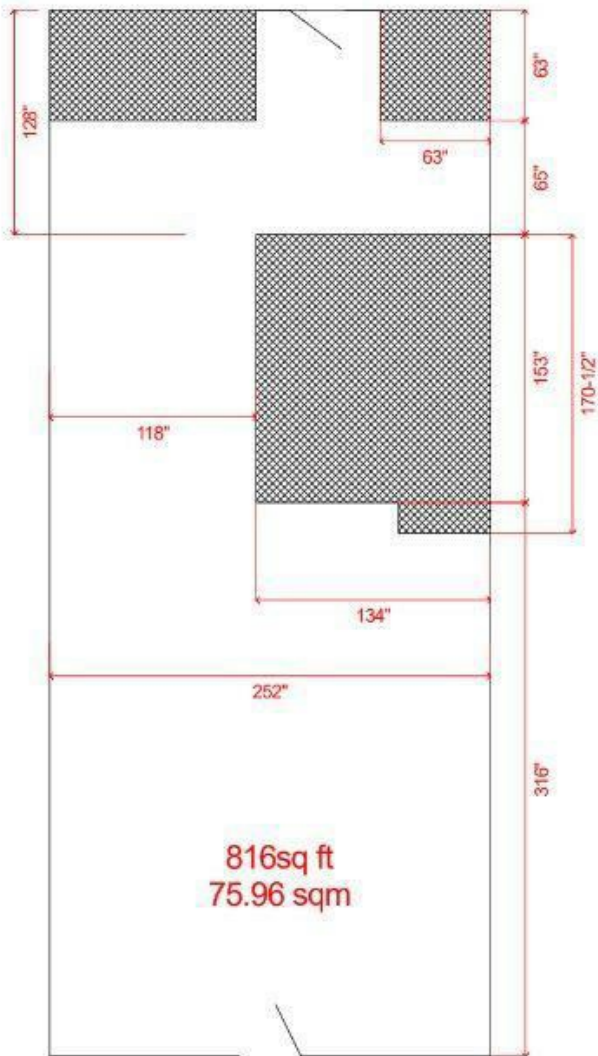
Location

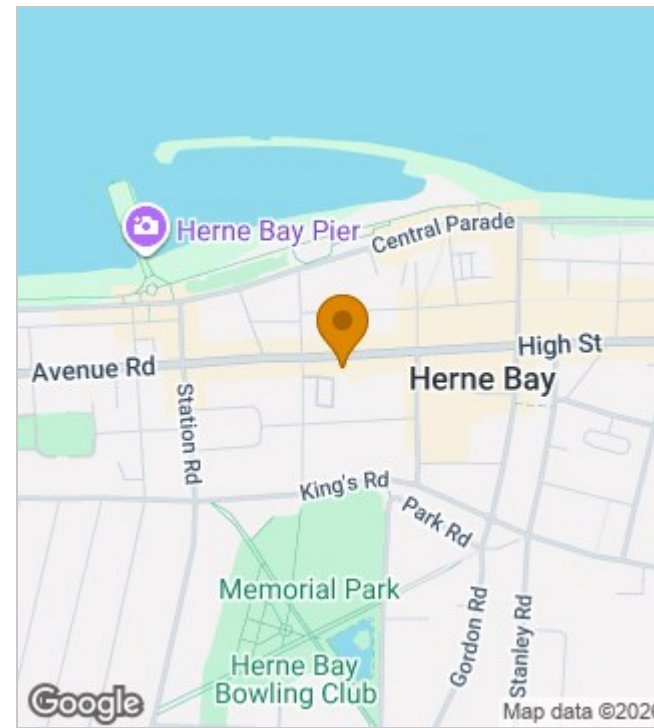
