Deceptively spacious inside and out, this home boasts a good size plot and is offered for sale with no onward chain.

The property itself briefly comprises of the entrance hallway, living room, kitchen/diner, utility and two storage rooms to the ground floor, with the landing, three bedrooms and family bathroom to the first floor. Externally, the property comes with well presented, low maintenance gardens to both the front and rear.

Ready for any buyer to make their own, viewings are now available by appointment only.



Hallway 10'9" x 5'11" (3.29 x 1.82)

Entrance to the property is via the front uPVC door and into the hallway. Wooden flooring with coving to the ceiling and central heating radiator. Internal doors lead to the living room and kitchen/diner, and carpeted stairs lead to the first floor accommodation.

Living Room 11'9" x 13'10" (3.59 x 4.22)

Carpeted with coving to the ceiling, central heating radiator, electric fireplace set on brick surround and uPVC bay window faces to the front of the property. Further uPVC window faces to the side of the property.

Kitchen/Diner 8'11" x 20'2" (2.73 x 6.16)

Mainly carpeted with part laminate flooring, coving to the ceiling, central heating radiator and uPVC window faces to the rear of the property. Base height units with countertop, tiled splashbacks, integrated sink and drainer and space for fridge/freezer. Window and door face to the utility.

Utility 6'0" x 7'1" (1.85 x 2.18)

Vinyl effect flooring with space and plumbing for white goods. Window and door lead to the rear garden.

Storage

Two storage spaces measuring 2.188m x 0.95m and 2.17m x 2.18m.

Landing 7'11" x 6'3" (2.43 x 1.91)

Carpeted with internal doors leading to all three bedrooms, bathroom and storage cupboard.

Bedroom One 10'9" x 11'9" (3.3 x 3.6)

Carpeted with central heating radiator and uPVC window faces to the front of the property.

Bedroom Two 13'6" x 8'8" (4.13 x 2.66)

Carpeted with central heating radiator and uPVC window faces to the rear of the property.

Bedroom Three 9'7" x 6'10" (2.93 x 2.09)

Carpeted with central heating radiator and uPVC window faces to the front of the property. Includes built in storage.

Bathroom 5'6" x 8'0" (1.7 x 2.44)

Vinyl effect flooring with coving to the ceiling, tiled walls, central heating radiator and two uPVC windows face to the

rear of the property. A three piece suite consisting of bathtub with overhead shower, sink and toilet.

External

To the front of the property is a well presented lawned garden with a pathway to the entrance of the property. The rear garden is low maintenance with grassed areas and established shrubs.
