

This predominantly front facing and part over dwelling house enjoys an attractive rear aspect with a pleasant view. This spacious 3 bedroom investment property is equipped with a central heating system and sealed unit double glazing and although arguably ready to be freshened up before being offered back to the rental market is in generally decent order. Given its convenient location and spacious accommodation this property is poised to attract a variety of tenants, making it an attractive investment opportunity. A fantastic opportunity for those looking to expand their property portfolio or begin their investment journey. Comprising; Living Kitchen, cellar, 3 beds, a bathroom and small front garden.



#### ACCOMMODATION

#### **GROUND FLOOR**

## ENTRANCE LOBBY 3'4" x 3'6" (1.03 x 1.09)

Accessed via a uPVC double glazed front door with privacy glass inset, with a staircase rising to the first floor, a central heating radiator and an internal door leading through to the living kitchen.

#### LIVING KITCHEN 13'9" 3'3"x 13'5" max (4.2 1x 4.10 max)

Fitted with a range of wall and base units with complementary working surfaces, part tiled splashbacks around the sink and worktops, adjacent to a PVC double glazed picture window. There is provision for an electric cooker, plumbing for a washing machine, a wall mounted Vaillant boiler, a gas fire (decorative only) and a central heating radiator. An internal door leads to the cellar steps which descend to the cellar.

#### FIRST FLOOR

#### LANDING 5'10" x 6'0" (1.78 x 1.85)

Galleried style landing with a loft hatch (not accessed at the time of the appraisal).

#### BEDROOM 1, front 14'3" x 10'4" (4.35 x 3.17)

With a central heating radiator and a uPVC double glazed window to the front elevation.

## BEDROOM 2, rear 13'9" x 10'5" max (4.21 x 3.19 max)

Enjoying an attractive aspect of woodland and beyond to the Colne Valley via a uPVC double glazed picture window, central heating radiator.

## BEDROOM 3 5'10" x 10'6" (1.79 x 3.22)

With a central heating radiator and a uPVC double glazed window with the aforementioned view.

#### BATHROOM 6'2" x 5'10" plus entrance (1.9 x 1.8 plus entrance)

Fitted with a panel bath with shower over, low flush wc, pedestal hand wash basin, part tiled splashbacks, central heating radiator and a uPVC double glazed window with privacy glass inset.

There is a small, low maintenance buffer garden to the front of the house




## Area Map
