To the rear is the recently fitted kitchen diner, a brilliant social space for hosting friends for a drink or bite to eat.

Completing the ground floor is the conservatory, a versatile space that could be used as a child's playroom, second sitting room or even a home office.

Upstairs are three bedrooms, two of which doubles with the main bedroom benefitting built in storage units and views of the fields and woodlands beyond.

Finalising the first floor is the modern bathroom, comprising a three piece suite with overhead shower above the bath. This space is tiled from top to bottom ideal for easy cleaning.

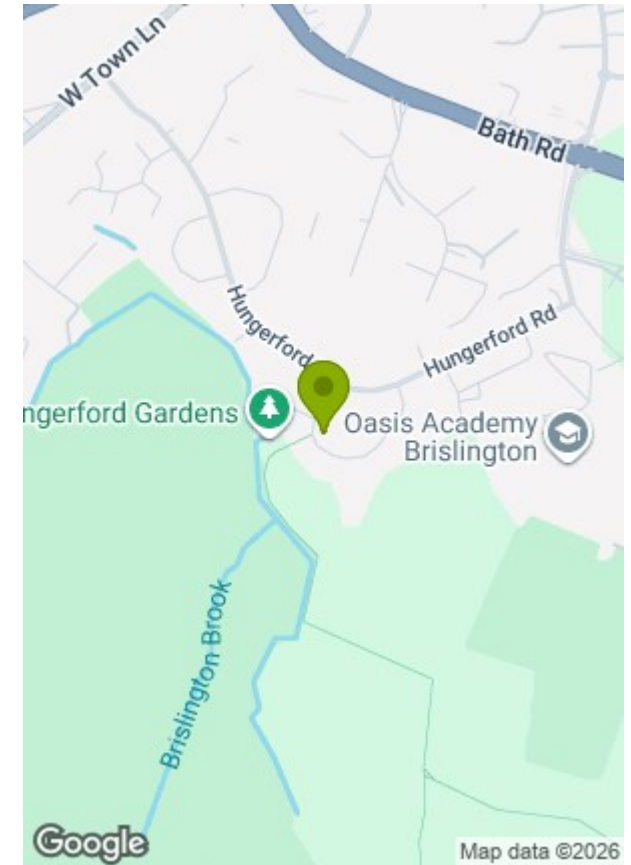
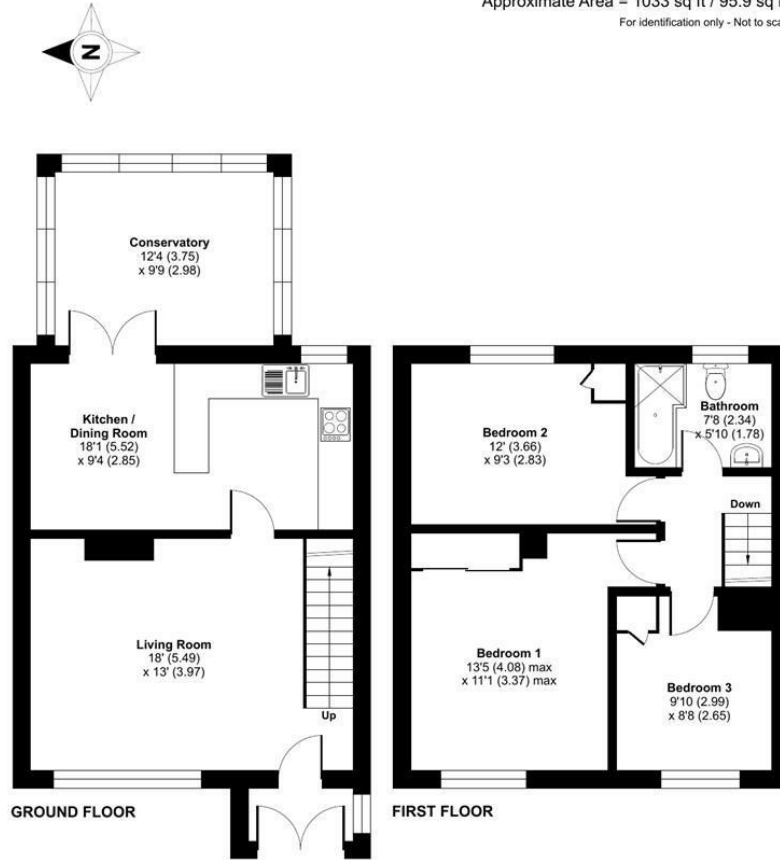
