Beautifully landscaped, low-maintenance garden with paved seating areas, lawn, decorative borders, a timber summer house, greenhouse and gated side access.

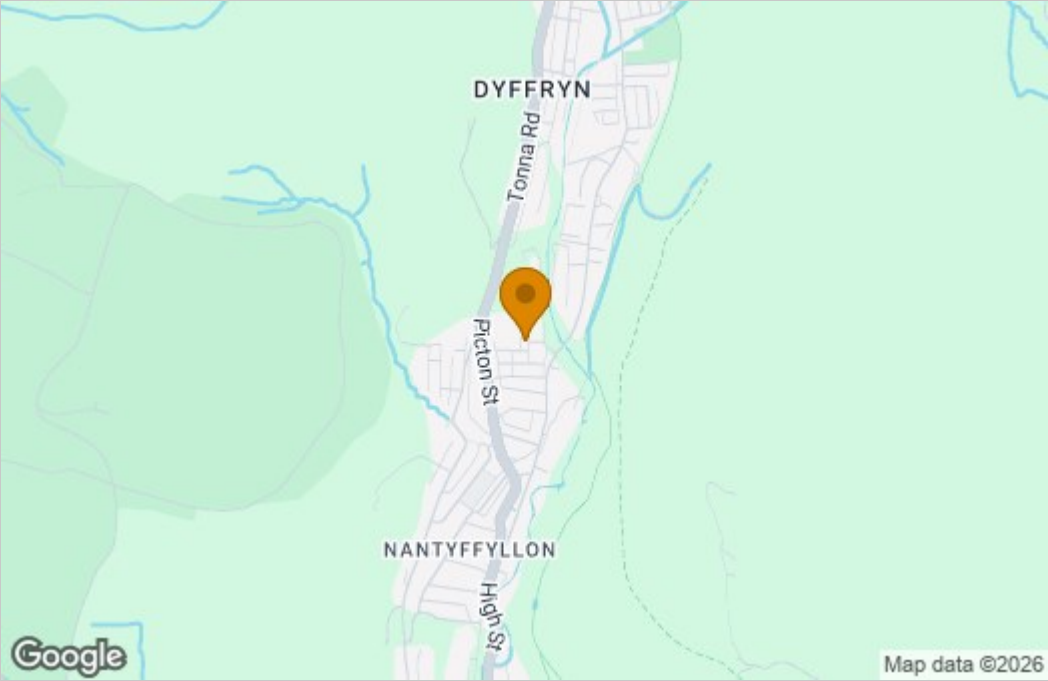

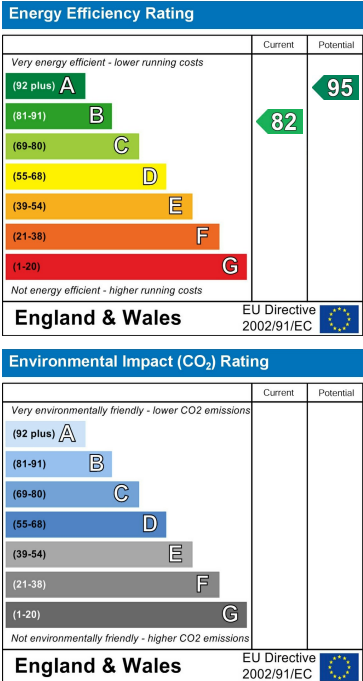
Floor Plan
