Set behind electric gates within one of Rowlands Castle's most prestigious and sought-after addresses, this exceptional detached residence occupies a magnificent plot extending to over half an acre and offers in excess of 4,700 sq ft of beautifully appointed accommodation and outbuildings. Extensively modernised, reconfigured and enlarged in 2019, the property seamlessly combines impressive proportions, contemporary styling and outstanding versatility, creating a truly remarkable family home.



Approached via a sweeping gated driveway providing extensive parking, the property immediately impresses with its commanding frontage, detached double garage and immaculate presentation. Internally, the accommodation has been thoughtfully designed to suit modern family living, with a superb balance of formal and informal reception space.

At the heart of the home is a stunning open-plan kitchen, dining and family room extending to over 35 feet in length, beautifully appointed with a substantial central island, extensive cabinetry and ample space for entertaining on both an intimate and grand scale. Large glazed doors frame views across the gardens and provide seamless access onto the outdoor entertaining areas. Complementing this impressive space are a generous sitting room, substantial games room, study and practical utility room, all arranged around a welcoming entrance hall.

The first floor provides exceptional flexibility with seven bedrooms arranged to accommodate a variety of family requirements. The principal suite is particularly impressive, featuring a spacious bedroom, dressing room and luxurious en-suite bathroom. Three further bath/shower rooms serve the remaining bedrooms. The property's intelligent design allows Bedrooms Two and Three to be combined into an expansive suite if desired, whilst Bedrooms Five and Six can similarly be interconnected, creating adaptable accommodation ideal for larger families, guests, teenagers or multi-generational living.

Externally, the grounds are a particular feature of the property. Beautifully manicured lawns extend across the rear garden, creating a wonderful sense of privacy and seclusion. Designed for both relaxation and entertaining, the outdoor space incorporates a superb swim spa, hot tub, elegant gazebo and summer house, providing a resort-style setting that can be enjoyed throughout the year. Mature planting and established boundaries further enhance the feeling of exclusivity, while the detached double garage offers excellent storage and secure parking.

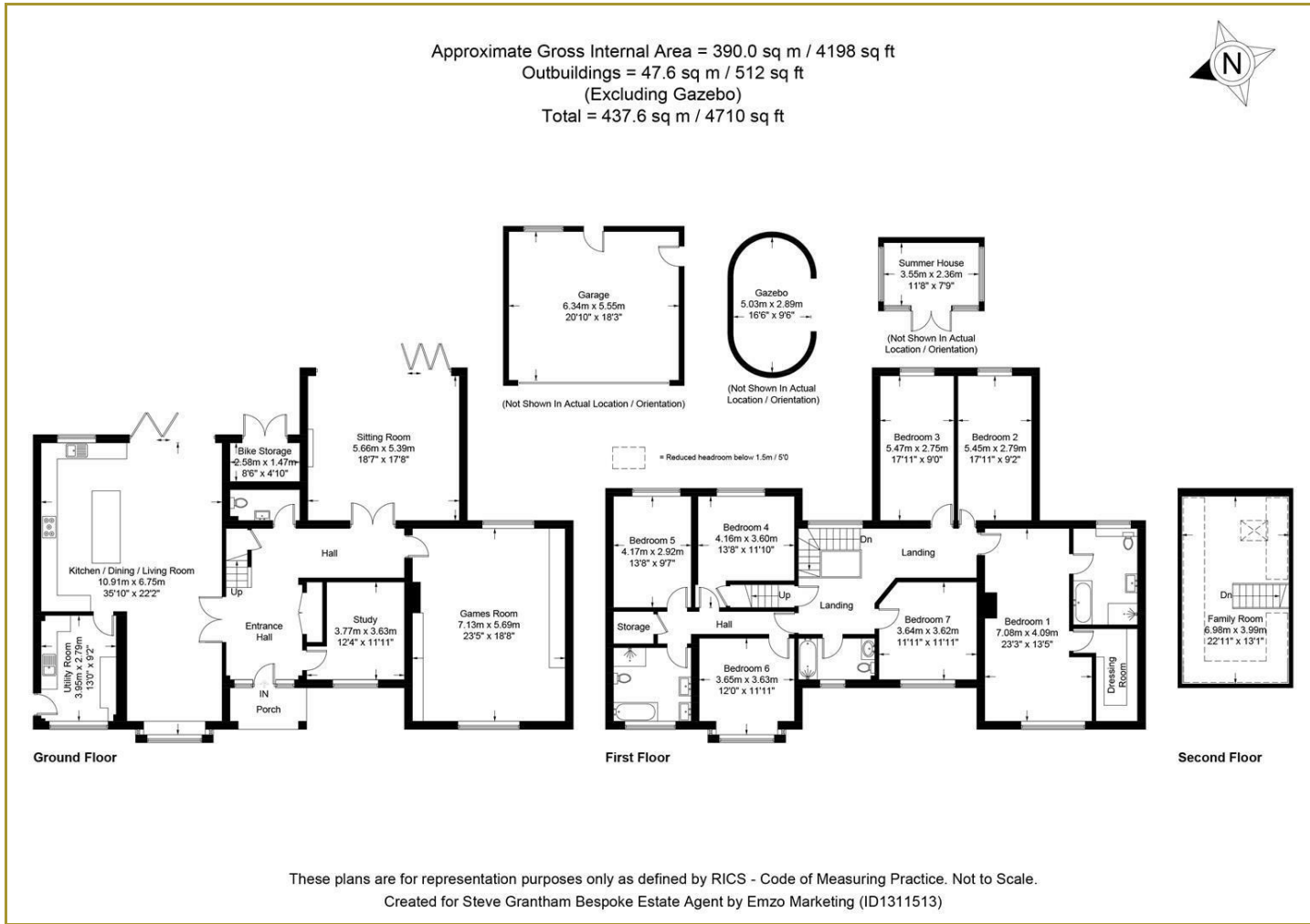

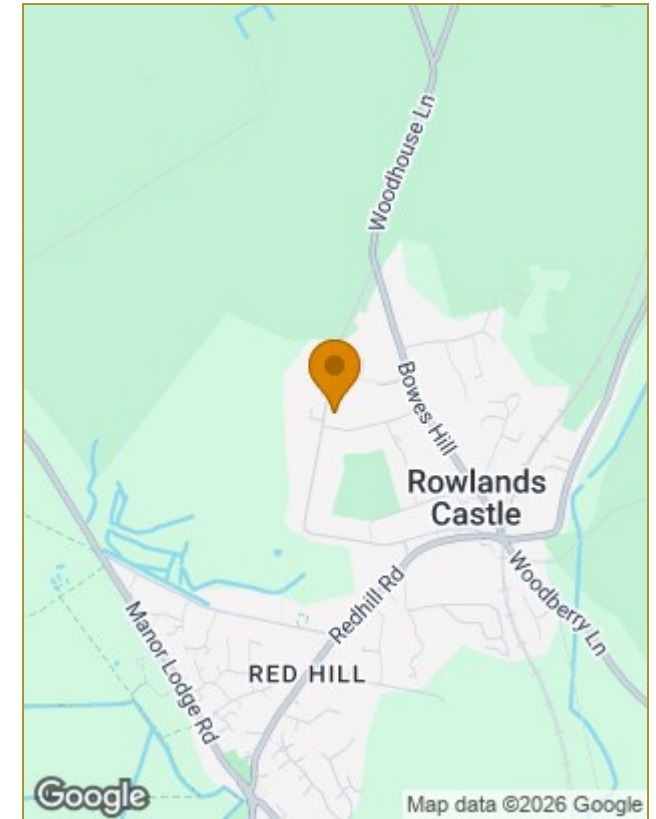

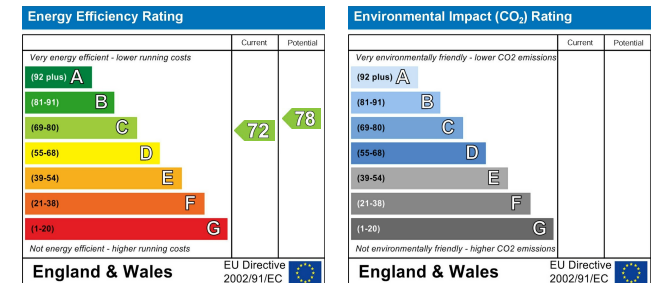
Floor Plans
