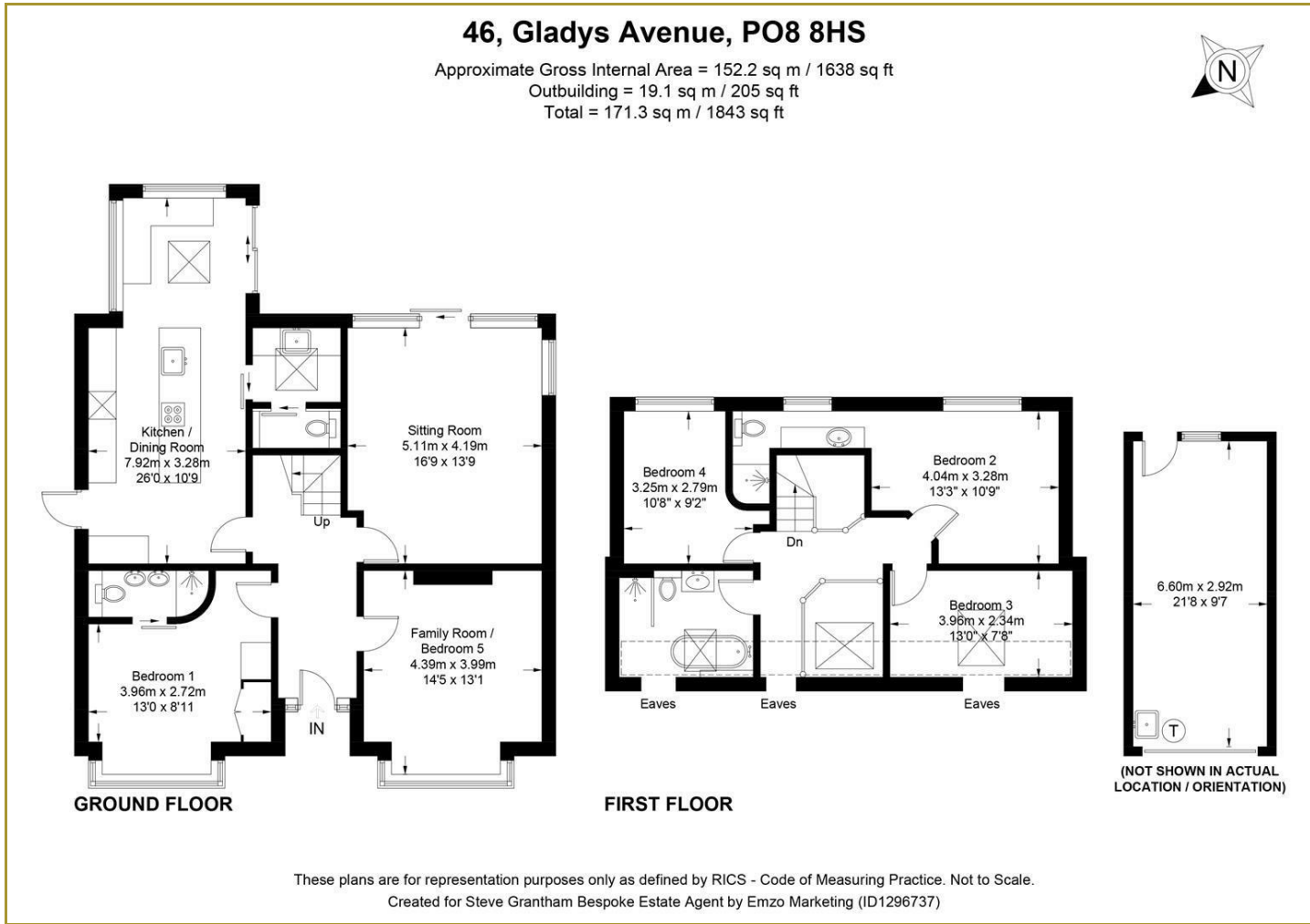

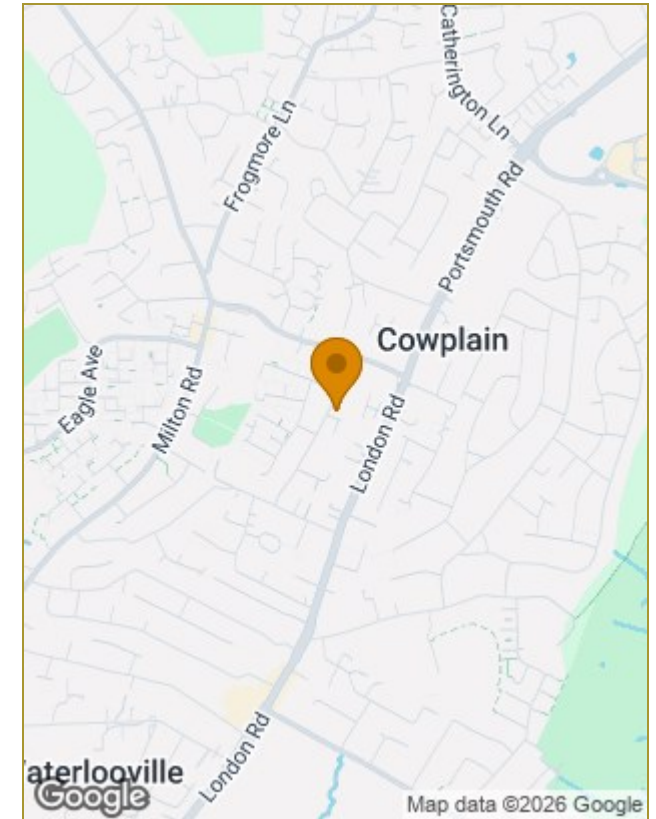




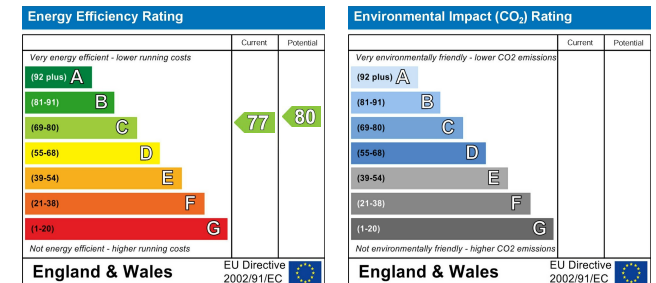
Floor Plans
